THIS MATTER having come before the Washington State Liquor Control Board (Board) and The Washington State Liquor Control Board Education and Enforcement Division (Enforcement) represented by and through its attorneys ROBERT M. MCKENNA, Attorney General and MARISA E. BROGGEL, Assistant Attorney General and Licensee JOAN ELLEN CORKILL-ENYEART d/b/a SAMIE ANNS ICE CREAM PARLOR (Licensee), and the parties having voluntarily entered into a stipulated settlement agreement for Administrative Violation Notice (AVN) No. 4P2083A, Case No. 24,077, and the Board having considered the stipulated settlement agreement and Enforcement's memorandum recommending acceptance of the settlement agreement, and the Board having had the opportunity to review the file materials maintained in this case, now, therefore:

IT IS HEREBY ORDERED that the allegations set forth in AVN No. 4P2083A, to wit: that on or around March 23, 2012, the Licensee or employee(s) thereof gave, sold and/or

1 otherwise supplied liquor to a person under the age of twenty-one (21), in violation of
2 RCW 66.44.270(1) and WAC 314-11-020(1), is sustained.

3 IT IS FURTHER ORDERED that the Licensee's cessation of business operations and
4 voluntarily relinquishing of its liquor license shall act in lieu of the standard penalty for this
5 violation, which is a five (5) day suspension of the Licensee's liquor license or a monetary
6 penalty of five hundred dollars (\$500).

The Washington State Liquor Control Board Education and Enforcement Division (Enforcement) represented by and through its attorneys, ROBERT M. MCKENNA, Attorney General and MARISA E. BROGGEL, Assistant Attorney General, and JOAN ELLEN CORKILL-ENYEART d/b/a SAMIE ANNS ICE CREAM PARLOR (Licensee), and hereby enter into this stipulated settlement agreement for Washington State Liquor Control Board (Board) Case No. 24,077, arising from Administrative Violation Notice No. 4P2083A.

I. INTRODUCTION

On or around March 27, 2012, Enforcement issued AVN No. 4P2083A to the Licensee, alleging that on or around March 23, 2012, the Licensee or employee(s) thereof gave, sold and/or otherwise supplied liquor to a person under the age of twenty-one (21), in violation of RCW 66.44.270(1) and WAC 314-11-020(1).

1 **II. AGREEMENT OF THE PARTIES**

2 Prior to scheduling an administrative hearing in this matter, Enforcement and the
3 Licensee have agreed to enter into the following Stipulated Settlement Agreement (Agreement)
4 concerning the above-referenced AVN. Enforcement and the Licensee agree to the following:

5 1. Enforcement and the Licensee enter into this Agreement to avoid the time and
6 expense of further litigation.

7 2. The Licensee explicitly waives the right to further administrative review of all
8 matters related to the above-referenced AVN No. 4P2083A. Furthermore, the Licensee hereby
9 voluntarily withdraws its request for a hearing in this matter.

10 3. This Agreement constitutes the final written expression of all the terms of this
11 Agreement and is a complete and exclusive statement of these terms.

12 4. The Licensee stipulates to the violation set forth in the above-referenced AVN.
13 Specifically, Licensee stipulates that on or around March 23, 2012, the Licensee or
14 employee(s) thereof gave, sold and/or otherwise supplied liquor to a person under the age of
15 twenty-one (21), in violation of RCW 66.44.270(1) and WAC 314-11-020(1).

16 5. The Licensee admits that this is the Licensee's first violation of this type within
17 a twenty-four month period, for which the standard penalty is a five (5) day suspension of the
18 Licensee's liquor license or a monetary penalty of five hundred dollars (\$500).

19 6. The Licensee stipulates that she ceased business operations on or around April
20 30, 2012, and voluntarily relinquished her liquor license with no further interest remaining in
21 the license.

22 7. The parties agree that the Licensee's cessation of business operations and
23 voluntarily relinquishing of her liquor license has effectively mooted AVN No. 4P2083A and
24 related administrative proceedings, and said surrender shall act in lieu of the standard penalty.

25 8. The parties recognize that this Agreement is subject to approval by the Board.

1 9. The undersigned parties declare that the terms of this Agreement are completely
2 read, wholly understood, and voluntarily accepted for the purpose of making a full and final
3 compromise and settlement of any and all violations arising from the above-referenced AVN.


