

FORD, Assistant Attorney General, and the Licensee, HWANGPO, JEONG HO d/b/a EVERETT MALL PARKWAY STATION, and the Board having considered the Stipulated Settlement Agreement and Enforcement's memorandum recommending acceptance of the Settlement Agreement, and the Board having had the opportunity to review the file materials maintained in this case, now therefore:

IT IS HEREBY ORDERED the Board accepts, adopts, and incorporates herein by reference the Stipulated Settlement Agreement between Enforcement and the Licensee in the above-captioned matter and further that the violation set forth in the Complaint dated

1 October 10, 2012 is sustained and there shall be no monetary penalty imposed for this
2 violation.

13 The Washington State Liquor Control Board Education and Enforcement Division
14 (Enforcement) represented by its attorneys ROBERT M. MCKENNA, Attorney General and
15 TIMOTHY D. FORD, Assistant Attorney General and the Licensee HWANGPO, JEONG HO
16 d/b/a EVERETT MALL PARKWAY STATION represented by JEONG HO HWANGPO, do
17 hereby enter into this stipulated settlement agreement for Liquor Control Board Case
18 No. 24,105. The above-referenced Licensee no longer owns the business, but for the purposes
19 of this action, is considered the Licensee and subject to the disciplinary action and a Final
20 Order of the Board.

21 **I. INTRODUCTION**

22 The Washington State Liquor Control Board, Enforcement and Education Division
23 charged the above-named Licensee, in Administrative Violation Notice (AVN) No. 3G2172J,
24 with the following alleged violation of the Washington State Liquor Control Board rules and
25 regulations:
26

1 On or about June 20, 2012, the above-named Licensee, or employee(s), gave, sold
2 and/or supplied liquor to a person(s) under the age of twenty-one (21), in violation of
3 RCW 66.44.270(1) and WAC 314-11-020(1).

4 Enforcement and the Licensee wish to enter into a settlement agreement concerning the
5 above-referenced AVN.

6 **II. AGREEMENT OF THE PARTIES**

7 Enforcement and the Licensee agree to the following:

8 1. Enforcement and the Licensee enter into this agreement to avoid the time and
9 expense of further litigation. The Licensee explicitly waives the right of further administrative
10 review of all matters related to the above-referenced violation and AVN. The Licensee hereby
11 voluntarily withdraws its request for a hearing in this matter.

12 2. This agreement constitutes the final written expression of all the terms of this
13 agreement and is a complete and exclusive statement of these terms.

14 3. The Licensee stipulates to the violation set forth above and referenced in the
15 AVN: On or about June 20, 2012, the above-named Licensee, or employee(s), gave, sold
16 and/or supplied liquor to a person(s) under the age of twenty-one (21), in violation of
17 RCW 66.44.270(1) and WAC 314-11-020(1).

18 4. The Licensee acknowledges this is the Licensee's first violation of this type
19 within a twenty-four (24) month period, which carries a standard penalty of a five (5) day
20 suspension of the license or five hundred dollars (\$500).

21 5. The Licensee's property and business was foreclosed, put into receivership and
22 liquidated. The business no longer exists. In consideration for stipulating to the violation as
23 charged in the AVN and also in consideration that the business no longer exists there shall be
24 no monetary penalty imposed for this violation.


25 6. The undersigned parties declare that the terms of this Settlement Agreement are
26 completely read, wholly understood, and voluntarily accepted for the purpose of making a full


1 and final compromise and settlement of any and all claims arising from the above-referenced

4 the Washington State Liquor Control Board.




