The Washington State Liquor Control Board Education and Enforcement Division (Enforcement) represented by its attorneys ROBERT M. MCKENNA, Attorney General and TIMOTHY D. FORD, Assistant Attorney General and the Licensee SKYBOUND, INC d/b/a SUNSET GROCERY represented by RONALD MAXEY, do hereby enter into this stipulated settlement agreement for Liquor Control Board Case No. 24,207. The above-referenced Licensee has since sold its business, but for the purposes of this action, is considered the Licensee and subject to the disciplinary action and a Final Order of the Board.

I. INTRODUCTION

The Washington State Liquor Control Board, Enforcement and Education Division charged the above-named Licensee, in Administrative Violation Notice (AVN) No. 4R2161A, with the following alleged violation of the Washington State Liquor Control Board rules and regulations:

On or about June 9, 2012, the above named Licensee, or employee(s) thereof, gave, sold and/or supplied liquor to a person(s) under the age of twenty-one (21) years, in violation of RCW 66.44.270 and WAC 314-11-020(1).

1 Enforcement and the Licensee wish to enter into a settlement agreement concerning the
2 above-referenced AVN.

3 II. AGREEMENT OF THE PARTIES

4 Enforcement and the Licensee agree to the following:

5 1. Enforcement and the Licensee enter into this agreement to avoid the time and
6 expense of further litigation. The Licensee explicitly waives the right of further administrative
7 review of all matters related to the above-referenced violation and AVN. The Licensee hereby
8 voluntarily withdraws its request for a hearing in this matter.

9 2. This agreement constitutes the final written expression of all the terms of this
10 agreement and is a complete and exclusive statement of these terms.

11 3. The Licensee stipulates to the violation set forth above and referenced in the
12 AVN: On or about June 9, 2012, the above named Licensee, or employee(s) thereof, gave, sold
13 and/or supplied liquor to a person(s) under the age of twenty-one (21) years, in violation of
14 RCW 66.44.270 and WAC 314-11-020(1).

15 4. The Licensee acknowledges this is the Licensee's third violation of this type
16 within a twenty-four (24) month period, which carries a standard penalty of a thirty (30) day
17 suspension of the license.

18 5. The Licensee sold the licensed premises SUNSET GROCERY and is no longer
19 the current Licensee for SKYBOUND, INC d/b/a SUNSET GROCERY. The violation
20 occurred on or about June 9, 2012 prior to the sale. The new Licensee is SPOKANE FINE
21 LIQUOR, INC. d/b/a SUNSET GROCERY. The new license was first issued June 14, 2012
22 and the governing person of the business license is ANKUR SOOD. RONALD MAXEY is no
23 longer a governing person for the new license or the Licensee.

24 In consideration for stipulating to the violation as charged in the AVN and also in
25 consideration that Licensee SKYBOUND, INC. d/b/a SUNSET GROCERY is no longer a
26 governing person on the current license and neither owns nor operates any part of the licensed

1 premises known as SUNSET GROCERY, there shall be no monetary penalty imposed for this
2 violation.

3 6. The undersigned parties declare that the terms of this Settlement Agreement are
4 completely read, wholly understood, and voluntarily accepted for the purpose of making a full
5 and final compromise and settlement of any and all claims arising from the above-referenced
6 AVN.

7 7. The parties recognize that this settlement agreement is subject to approval by
8 the Washington State Liquor Control Board.




