
15 THIS MATTER having come before the Washington State Liquor Control Board

24 in this case, now therefore:


25 IT IS HEREBY ORDERED that the Stipulated Settlement Agreement in the above

STIPULATED SETTLEMENT
AGREEMENT

The Washington State Liquor Control Board Education and Enforcement Division (Enforcement) represented by through its attorneys, ROBERT W. FERGUSON, Attorney General and MARISA E. BROGGEL, Assistant Attorney General and BIGELOW'S INC. d/b/a MUG SHOTS, Licensee, hereby enter into this stipulated settlement agreement for Washington State Liquor Control Board (Board) Case No. 23,730, arising from Administrative Violation Notice No. 4Q3035A.

I. INTRODUCTION

On or around February 5, 2013, The Washington State Liquor Control Board Enforcement and Education Division (Enforcement) issued AVN No. 4Q3035A to the Licensee, alleging that on or around February 4, 2013, the Licensee or employee(s) thereof,

1 gave, sold or otherwise supplied liquor to a person or persons under the age of twenty-one (21),
2 in violation of WAC 314-11-020 and RCW 66.44.270(1).

3 Prior to scheduling an administrative hearing in this matter, Enforcement and the
4 Licensee have agreed to enter into the following Stipulated Settlement Agreement (Agreement)
5 concerning the above-referenced AVN.

6 **II. AGREEMENT OF THE PARTIES**

7 Enforcement and the Licensee agree to the following:

8 1. Enforcement and the Licensee enter into this Agreement to avoid the time and
9 expense of further litigation.

10 2. The Licensee explicitly waives the right to further administrative review of all
11 matters related to the above-referenced AVN No. 4Q3035A. Furthermore, the Licensee hereby
12 voluntarily withdraws its request for a hearing in this matter.

13 3. This Agreement constitutes the final written expression of all the terms of this
14 Agreement and is a complete and exclusive statement of these terms.

15 4. The Licensee stipulates to the violation set forth in the above-referenced AVN.
16 Specifically, Licensee stipulates that on or around February 4, 2013, the Licensee or
17 employee(s) thereof, gave, sold or otherwise supplied liquor to a person or persons under the
18 age of twenty-one (21), in violation of WAC 314-11-020 and RCW 66.44.270(1).

19 5. The parties agree that the Licensee ceased business operations on or around
20 August 15, 2013 and the Licensee voluntarily relinquished Liquor License No. 081304 with no
21 further interest remaining in the license.

22 6. The parties agree that the Licensee's cessation of business operations and
23 voluntary surrender of its liquor license has effectively mooted AVN No. 4Q3035A and related
24 administrative proceedings, and that this license surrender shall act in lieu of the standard
25 penalty.

1 7. The parties recognize that this Agreement is subject to approval by the Board.

2 8. The undersigned parties declare that the terms of this Agreement are completely
3 read, wholly understood, and voluntarily accepted for the purpose of making a full and final
4 compromise and settlement of any and all violations arising from the above-referenced AVN.


