20 having voluntarily entered into a stipulated settlement agreement for case number 24,839, and
21 the Board having considered the Stipulated Settlement Agreement and Enforcement's
22 Memorandum recommending acceptance of the Stipulated Settlement Agreement, and the
23 Board having had the opportunity to review the file materials maintained in this case, now
24 therefore:

25 IT IS HEREBY ORDERED that the Stipulated Settlement Agreement in the above
26 captioned case is adopted in its entirety; and the AVN for Case Number 24,839 is sustained.


1 Licensee shall pay three hundred dollars (\$300) no later than thirty (30) days after the date of

6 In the event that the Licensee fails to make full and timely payment of the three
7 hundred dollar (\$300) monetary penalty, a five (5) day suspension of the Licensee's liquor

9 Liquor Control Board.

I. INTRODUCTION




