21 parties having voluntarily entered into a stipulated settlement agreement for case number
22 24,841, and the Board having considered the Stipulated Settlement Agreement and
23 Enforcement's Memorandum recommending acceptance of the Stipulated Settlement
24 Agreement, and the Board having had the opportunity to review the file materials maintained
25 in this case, now therefore:

26 IT IS HEREBY ORDERED that the Stipulated Settlement Agreement in the above


1 captioned case is adopted in its entirety; and the AVN for Case Number 24,841 is sustained.

I. INTRODUCTION




