
1 Licensee shall pay one hundred dollars (\$100) no later than thirty (30) days after the date of the

The Washington State Liquor Control Board Education and Enforcement Division (Enforcement), by and through its attorneys, ROBERT W. FERGUSON, Attorney General, and JENNIFER ELIAS, Assistant Attorney General, and BRIELLE SAUNDERS (Permit Holder) by and through her attorney, SCOTT STAFNE, hereby enter into this stipulated settlement agreement for Liquor Control Board (LCB) case number 24,965.

I. INTRODUCTION

The Washington State Liquor Control Board, Enforcement and Education Division issued administrative violation notice (AVN) 3E3323A to the Permit Holder alleging that on or about October 10, 2013, the Permit Holder thereof gave, sold and/or otherwise supplied liquor to a person under twenty-one years of age contrary to RCW 66.44.270(1).

1 **II. AGREEMENT OF THE PARTIES**

2 Enforcement and the Permit Holder agree to the following:

3 1. The parties enter into this Agreement to avoid the time and expense of further
4 litigation.

5 2. The Permit Holder explicitly waives the right of further administrative review
6 of all matters related to the above-referenced AVN. The Permit Holder hereby voluntarily
7 withdraws her request for a hearing in this matter.

8 3. This Agreement constitutes the final written expression of all the terms of this
9 Agreement, and it is a complete and exclusive statement of these terms.

10 4. The Permit Holder admits to the violation set forth in AVN 3E3323A.
11 Specifically, that on or about October 10, 2013, the Permit Holder gave, sold and/or otherwise
12 supplied liquor to a person under twenty-one years of age contrary to 66.44.270(1).

13 5. The Permit Holder acknowledges that the above referenced violation is the
14 Permit Holder's first violation within a twenty-four (24) month period, for which the standard
15 penalty is suspension of the Permit Holder's liquor license for five (5) days or a monetary
16 penalty of two hundred dollars (\$200).

17 6. The Permit Holder agrees to pay a monetary penalty of one hundred dollars
18 (\$100) within thirty (30) days of the date of the Final Order of the Board, no later than
19 4:00 p.m. on the applicable date, for the violations stipulated to in Section II, Paragraph 4.



23 7. In the event that the Permit Holder fails to make the full payment of the
24 monetary penalty on time, as set out and required by Section II, Paragraph 6, the Permit Holder
25 shall be subject to a five (5) day suspension of her MAST Permit the date and time of
26 suspension to be set by the Board.

1 8. The parties recognize that this settlement agreement is subject to approval by
2 the Washington State Liquor Control Board.




