FINAL ORDER OF THE BOARD



The Washington State Liquor Control Board Enforcement and Education Division ("Enforcement") represented by its attorneys ROBERT W. FERGUSON, Attorney General, and SUSIE GILES-KLEIN, Assistant Attorney General, and the Licensee WINTERGARDEN HOSPITALITY GROUP, LLC d/b/a SUITE RESTAURANT/LOUNGE, represented by its attorney, SCHUYLER T. WALLACE, hereby enter into this stipulated settlement agreement for Liquor Control Board Case Nos. L-24,977 and L-25,421.

**I. INTRODUCTION**

1. Enforcement charged the above-named Licensee in Complaint No. L-24,977/AVN No. 3W4033B alleging that: on or about February 2, 2014, the above-named Licensee, or employee(s) thereof, served and/or sold liquor to an apparently intoxicated person on the licensed premises, and/or allowed an apparently intoxicated person to consume and/or possess liquor on the licensed premises, contrary to WAC 314-16-150.

1           5.     In light of this Settlement Agreement, the parties acknowledge that LCB No.  
2 L-25,421 is a first violation of WAC 314-16-150. The standard penalty for a first violation of  
3 this type within a twenty-four (24) month period is five hundred dollars (\$500) or a five (5)  
4 day suspension of the liquor license.

5           6.     The Licensee agrees to pay the standard penalty of five hundred dollars (\$500).  
6 This amount shall be paid within thirty (30) days of the date of the final order of the Board.

7 **Payment shall be made no later than 4:00 p.m. on the applicable date and sent to:**

10          7.     In the event the Licensee fails to make full and timely payment of the monetary  
11 penalty as required in Section II, Paragraph 6, the Licensee shall serve the standard penalty of a  
12 five (5) day suspension of its liquor license, the dates and times of which shall be set by the  
13 Board.

14          8.     This Settlement Agreement constitutes the final written expression of all the  
15 terms of the parties' agreement, and is a complete and exclusive statement of these terms.

16          9.     The undersigned parties declare that the terms of this Settlement Agreement are  
17 completely read, wholly understood, and voluntarily accepted for the purpose of making a full  
18 and final settlement of any and all claims arising from the above referenced AVNs.
