The above-captioned matter coming on regularly before the Board, and it appearing that:

1. The Liquor Control Board issued a complaint dated June 30, 2014, alleging that on January 11, 2014 the above-named Licensee, or employee(s) thereof, served and/or sold liquor to an apparently intoxicated person on the licensed premises, and/or allowed an apparently intoxicated person(s) to consume and/or possess liquor on the licensed premises, contrary to WAC 314-16-150.
2. The Licensee made a timely request for a hearing.
3. Prior to a hearing, the parties entered into a Stipulated Settlement Agreement.

The entire record in this proceeding was presented to the Board for final decision, and the Board having fully considered said record and being fully advised in the premises; NOW, THEREFORE, IT IS HEREBY ORDERED that the Stipulated Settlement Agreement in the above captioned case is adopted in its entirety.


IT IS HEREBY FURTHER ORDERED that the liquor license privileges granted to Sara Ann Richardson d/b/a U-Dub Sports Pub and Grub, License No. 355551, are hereby suspended for a term of five (5) days. In lieu of a license suspension, the Licensee may pay a monetary penalty in the amount of five hundred dollars (\$500.00) due within 30 days of this order. If timely payment is not received, the suspension will take place from 11:00 a.m. on Thursday, November 13, 2014 until 11:00 a.m. on Tuesday, November 18, 2014. Failure to comply with the terms of this order will result in further disciplinary action.

16 The Washington State Liquor Control Board Education and Enforcement Division
17 (Enforcement) represented by its attorneys ROBERT W. FERGUSON, Attorney General, and
18 SUSIE GILES-KLEIN, Assistant Attorney General, and the Licensee SARA ANN
19 RICHARDSON d/b/a U-DUB SPORTS PUB AND GRUB, hereby enter into this stipulated
20 settlement agreement for Liquor Control Board Case No. L-24,986.

21 **I. INTRODUCTION**

22 The Washington State Liquor Control Board, Enforcement and Education Division
23 charged the above-named Licensee in Administrative Violation Notice ("AVN") No.
24 1K4011A with the following alleged violation of the Washington State Liquor Control Board
25 rules and regulations:

1 On or about January 11, 2014, the above-named Licensee, or employee(s) thereof,
2 served and/ or sold liquor to an apparently intoxicated person on the licensed premises,
3 contrary to WAC 314-16-150.

4 Enforcement and the Licensee wish to enter into a settlement agreement concerning the
5 above-referenced AVN.

6 II. AGREEMENT OF THE PARTIES

7 Enforcement and the Licensee agree to the following:

8 1. Enforcement and the Licensee enter into this agreement to avoid the time and
9 expense of further litigation.

10 2. The Licensee explicitly waives the right of further administrative review of all
11 matters related to the above-referenced AVN. The Licensee hereby voluntarily withdraws its
12 requests for a hearing in this matter.

13 3. This agreement constitutes the final written expression of all the terms of this
14 agreement and is a complete and exclusive statement of these terms.

15 4. The Licensee stipulates to the violation set forth above and referenced in the
16 AVN, specifically: January 11, 2014, the above-named Licensee, or employee(s) thereof,
17 served and/ or sold liquor to an apparently intoxicated person on the licensed premises,
18 contrary to WAC 314-16-150.

19 5. The Licensee acknowledges this is the Licensee's first violation of this type
20 within a twenty-four (24) month period, which carries a standard monetary penalty of five
21 hundred dollars (\$500.00) or a five (5) day suspension of the license. This amount shall be paid
22 within thirty (30) days of the date of the final order of the Board. **Payment shall be made no**
23 **later than 4:00 p.m. on the applicable date and sent to:**


1 7. In the event the Licensee fails to make full and timely payment of the monetary
2 penalty as required in Section II, Paragraph 5, the Licensee shall serve the standard penalty of a
3 five (5) day suspension of its liquor license, the dates and times of which shall be set by the
4 Board:

5 8. The undersigned parties declare that the terms of this Settlement Agreement are
6 completely read, wholly understood, and voluntarily accepted for the purpose of making a full
7 and final compromise and settlement of any and all claims arising from the above referenced
8 AVN.


9 9. The parties recognize that this settlement agreement is subject to approval by




