The Washington State Liquor Control Board Enforcement and Education Division ("Enforcement") represented by its attorneys ROBERT W. FERGUSON, Attorney General, and SUSIE GILES-KLEIN, Assistant Attorney General, and the Licensee JOSE OCAMPO d/b/a CIRCLE INN, hereby enter into this stipulated settlement agreement for Liquor Control Board Case No. L-25,004.

I. INTRODUCTION

Enforcement charged the above-named Licensee in Administrative Violation Notice ("AVN") No. 4D4037B with the following alleged violation of the Washington State Liquor Control Board rules and regulations:

On or about January 26, 2014, the above-named Licensee was apparently intoxicated on the licensed premises, contrary to WAC 314-11-015(3)(a).

1 Enforcement and the Licensee wish to enter into a settlement agreement concerning the  
2 above-referenced AVN.

3 **II. AGREEMENT OF THE PARTIES**

4 Enforcement and the Licensee agree to the following:

5 1. Enforcement and the Licensee enter into this agreement to avoid the time and  
6 expense of further litigation.

7 2. The Licensee explicitly waives the right of further administrative review of all  
8 matters related to the above-referenced AVN. The Licensee hereby voluntarily withdraws its  
9 request for a hearing in this matter.

10 3. This agreement constitutes the final written expression of all the terms of this  
11 agreement and is a complete and exclusive statement of these terms.

12 4. The Licensee stipulates to the violation set forth above and referenced in the  
13 AVN, specifically: on or about January 26, 2014, the above-named Licensee was apparently  
14 intoxicated on the licensed premises, contrary to WAC 314-11-015(3)(a).

15 5. The Licensee acknowledges this is the Licensee's first violation of this type  
16 within a twenty-four (24) month period, which carries a standard monetary penalty of five  
17 hundred dollars (\$500.00) or a five (5) day suspension of the license.

18 6. In consideration of the Licensee's agreement not to pursue further  
19 administrative review, the Washington State Liquor Control Board agrees to reduce the  
20 monetary penalty to three hundred dollars (\$300). This amount shall be paid within thirty (30)  
21 days of the date of the final order of the Board. **Payment shall be made no later than**  
22 **4:00 p.m. on the applicable date and sent to:**

25 7. In the event the Licensee fails to make full and timely payment of the monetary  
26 penalty as required in Section II, Paragraph 6, the Licensee shall serve the standard penalty of a

1 five (5) day suspension of its liquor license, the dates and times of which shall be set by the  
2 Board.

3 8. The undersigned parties declare that the terms of this Settlement Agreement are  
4 completely read, wholly understood, and voluntarily accepted for the purpose of making a full  
5 and final compromise and settlement of any and all claims arising from the above referenced  
6 AVN.

7 9. The parties recognize that this settlement agreement is subject to approval by  
8 the Board.




