

The Washington State Liquor Control Board Enforcement and Education Division ("Enforcement") represented by its attorneys ROBERT W. FERGUSON, Attorney General, and SUSIE GILES-KLEIN, Assistant Attorney General, and the Licensee ROYAL T, INC. d/b/a CAP'S, hereby enter into this stipulated settlement agreement for Liquor Control Board Case No. L-25,031.

I. INTRODUCTION

Enforcement charged the above-named Licensee in Administrative Violation Notice ("AVN") No. 3B4102A with the following alleged violation of the Washington State Liquor Control Board rules and regulations:

On or about April 12, 2014, the above-named Licensee, or employee(s) thereof, served and/ or sold liquor to an apparently intoxicated person on the licensed premises, and/or allowed an apparently intoxicated person to consume and/or possess liquor on the licensed premises, contrary to WAC 314-16-150.

1 Enforcement and the Licensee wish to enter into a settlement agreement concerning the
2 above-referenced AVN.

3 **II. AGREEMENT OF THE PARTIES**

4 Enforcement and the Licensee agree to the following:

5 1. Enforcement and the Licensee enter into this agreement to avoid the time and
6 expense of further litigation.

7 2. The Licensee explicitly waives the right of further administrative review of all
8 matters related to the above-referenced AVN. The Licensee hereby voluntarily withdraws its
9 request for a hearing in this matter.

10 3. This agreement constitutes the final written expression of all the terms of this
11 agreement and is a complete and exclusive statement of these terms.

12 4. The Licensee stipulates to the violation set forth above and referenced in the
13 AVN, specifically: On or about April 12, 2014, the above-named Licensee, or employee(s)
14 thereof, served and/ or sold liquor to an apparently intoxicated person on the licensed premises,
15 and/or allowed an apparently intoxicated person to consume and/or possess liquor on the
16 licensed premises, contrary to WAC 314-16-150.

17 5. The Licensee acknowledges this is the Licensee's first violation of this type
18 within a twenty-four (24) month period, which carries a standard monetary penalty of five
19 hundred dollars (\$500.00) or a five (5) day suspension of the license.

20 6. In consideration of the Licensee's agreement not to pursue further
21 administrative review, the Washington State Liquor Control Board agrees to reduce the
22 monetary penalty to three hundred dollars (\$300). This amount shall be paid within thirty (30)
23 days of the date of the final order of the Board. **Payment shall be made no later than**
24 **4:00 p.m. on the applicable date and sent to:**


1 7. In the event the Licensee fails to make full and timely payment of the monetary
2 penalty as required in Section II, Paragraph 6, the Licensee shall serve the standard penalty of a
3 five (5) day suspension of its liquor license, the dates and times of which shall be set by the
4 Board.

5 8. The undersigned parties declare that the terms of this Settlement Agreement are
6 completely read, wholly understood, and voluntarily accepted for the purpose of making a full
7 and final compromise and settlement of any and all claims arising from the above referenced
8 AVN.

9 9. The parties recognize that this settlement agreement is subject to approval by
10 the Board.


