FINAL ORDER OF THE BOARD

The above-captioned matter coming on regularly before the Board, and it appearing that:

1. On June 4, 2014, the Board issued an Emergency Order of Suspension pursuant to RCW 66.08.150(4) in the above-captioned cause, in which the Board entered Findings of Fact and Conclusions of Law supporting the emergency suspension of the Licensee's liquor license.
2. On June 4, 2014, the Enforcement and Education Division served on the Licensee, PAULY'S NITECLUB LLC d/b/a PAULY'S NITECLUB, a Complaint in LCB No. L-25,104, based upon Administrative Violation Notice (AVN) No. 1L4142A charging that between February 16, 2014 and May 18, 2014, the above-named Licensee, and/or employee(s) thereof engaged in or allowed conduct on the licensed premises that is prohibited by Chapter 69, RCW, specifically, the sale and/or delivery of Marijuana, a controlled substance, prohibited by RCW 69.50.401(1), in violation of WAC 314-11-015(2), which conduct presents a threat to public safety contrary to WAC 314-11-015(3)(c).


3. On June 4, 2014, the Enforcement and Education Division served the Emergency Order of Suspension on the Licensee, PAULY'S NITECLUB LLC d/b/a PAULY'S NITECLUB, which informed the Licensee of its right to request a hearing to challenge the revocation within twenty (20) days of service.
4. Pursuant to the Emergency Order of Suspension, the Board ordered that the liquor license privileges of the Licensee be revoked, subject to any lawful appeal exercised by the Licensee. The period to timely request a hearing on revocation expired on June 24, 2014, with the Licensee having failed to request a hearing to challenge the emergency suspension or the revocation of its liquor license privileges. Now therefore,

IT IS HEREBY ORDERED that the liquor license privileges of PAULY'S NITECLUB LLC d/b/a PAULY'S NITECLUB (license no. 410908) located at 47 SW Russell Ave Ste B in Stevenson, Washington, continue to be suspended until November 30, 2014, pursuant to the Board's June 4, 2014 Order of Emergency Suspension. The Liquor License privileges of PAULY'S NITECLUB LLC d/b/a PAULY'S NITECLUB (license no. 410908) located at 47 SW Russell Ave Ste B in Stevenson, Washington, are hereby REVOKED effective immediately following the end of the suspension period.

Reconsideration. Pursuant to RCW 34.05.470, you have ten (10) days from the mailing of this Order to file a petition for reconsideration stating the specific grounds on which relief is requested. A petition for reconsideration, together with any argument in support thereof, should be filed by mailing or delivering it directly to the Washington State Liquor Control Board, Attn: Kevin McCarroll, 3000 Pacific Avenue Southeast, PO Box 43076, Olympia, WA 98504-3076, with a copy to all other parties of record and their representatives. Filing means actual receipt of the document at the Board's office. RCW 34.05.010(6). A copy shall also be sent to Mary M. Tennyson, Senior Assistant Attorney General, 1125 Washington St. SE, P.O. Box 40110, Olympia, WA 98504-0110. A timely petition for reconsideration is deemed to be denied if, within twenty (20) days from the date the petition is filed, the agency does not (a) dispose of the petition or (b) serve the parties with a written notice specifying the date by which it will act on the petition. An order denying reconsideration is not subject to judicial review. RCW 34.05.470(5). The filing of a petition for reconsideration is not a prerequisite for filing a petition for judicial review.

Stay of Effectiveness. The filing of a petition for reconsideration does not stay the effectiveness of this Order. The Board has determined not to consider a petition to stay the effectiveness of this Order. Any such request should be made in connection with a petition for judicial review under chapter 34.05 RCW and RCW 34.05.550.

Judicial Review. Proceedings for judicial review may be instituted by filing a petition in superior court according to the procedures specified in chapter 34.05 RCW, Part V, Judicial Review and Civil Enforcement. The petition for judicial review of this Order shall be filed with the appropriate court and served on the Board, the Office of the Attorney General, and all parties within thirty days after service of the final order, as provided in RCW 34.05.542.


