The above-captioned matter coming on regularly before the Board, and it appearing that:


1. The Licensing Division of the Liquor Control Board issued a Statement of Intent to Revoke Liquor License dated August 27, 2014 asserting that Mr. Kil Su Kim accrued 10 criminal history points and failed to disclose a 2003 conviction on his 2010 Personal/Criminal History Statement when he applied for a liquor license.
2. The Licensee timely submitted a request for a hearing.
3. On March 16, 2015, the Licensee's attorney filed with the Office of Administrative Hearings a withdrawal of the request for a hearing in this matter.
4. On March 17, 2015, Administrative Law Judge Gina L. Hale issued an Initial Order of Dismissal based on withdrawal.
5. The entire record in this proceeding was presented to the Board for final decision, and the Board having fully considered said record and being fully advised in the premises; NOW,


THEREFORE, IT IS HEREBY ORDERED that the Statement of Intent to Revoke Liquor License for case L-25,333 in this matter is ADOPTED.

IT IS HEREBY FURTHER ORDERED that liquor license number 075231 for Summit Restaurant & Bar LLC d/b/a Summit Inn & Restaurant is REVOKED.


