20 voluntarily entered into a stipulated settlement agreement for case number L-25,336, and the
21 Board having considered the Stipulated Settlement Agreement and Enforcement's

26 captioned case is adopted in its entirety; and the administrative violation notice (AVN)


1 3B4217A for Case Number L-25,336 is sustained. Licensee shall pay three hundred dollars

The Washington State Liquor Control Board Education and Enforcement Division (Enforcement), by and through its attorneys, ROBERT W. FERGUSON, Attorney General, and ARYNA ANDERSON, Assistant Attorney General, and SAJJAN, INC., d/b/a JJ'S IN AND OUT (Licensee) by and through its representative, SANJAY CHANAN, hereby enter into this stipulated settlement agreement for Liquor Control Board (LCB) case number L-25,336.

I. INTRODUCTION

The Washington State Liquor Control Board, Enforcement and Education Division issued administrative violation notice (AVN) 3B4217A to the Licensee alleging that on or about August 5, 2014, the Licensee or an employee(s) thereof gave, sold and/or otherwise supplied liquor to a person under twenty-one years of age contrary to RCW 66.44.270(1) and WAC 314.11.020(1).

1 **II. AGREEMENT OF THE PARTIES**

2 Enforcement and the Licensee agree to the following:

3 1. The parties enter into this Agreement to avoid the time and expense of further
4 litigation.

5 2. The Licensee explicitly waives the right of further administrative review of all
6 matters related to the above-referenced AVN. The Licensee hereby voluntarily withdraws its
7 request for a hearing in this matter.

8 3. This Agreement constitutes the final written expression of all the terms of this
9 Agreement, and it is a complete and exclusive statement of these terms.

10 4. The Licensee admits to the violations set forth in AVN 3B4217A. Specifically,
11 that on or about August 5, 2014, the Licensee or an employee(s) thereof gave, sold and/or
12 otherwise supplied liquor to a person under twenty-one years of age contrary to 66.44.270(1)
13 and WAC 314.11.020(1).

14 5. The Licensee acknowledges that the above referenced violation is the Licensee's
15 first violation within a twenty-four (24) month period, for which the standard penalty is
16 suspension of the Licensee's liquor license for five (5) days or a monetary penalty of five
17 hundred dollars (\$500).

18 6. The Licensee agrees to pay a monetary penalty of three hundred dollars (\$300)
19 within thirty (30) days of the date of the Final Order of the Board, no later than 4:00 p.m. on the
20 applicable date, for the violations stipulated to in Section II, Paragraph 4. **Payment shall be**


25 7. In the event that the Licensee fails to make the full payment of the monetary
26 penalty on time, as set out and required by Section II, Paragraph 6, the Licensee shall be subject

1 to a five (5) day suspension of its liquor license, the date and time of suspension to be set by the
2 Board.


3 8. The parties recognize that this settlement agreement is subject to approval by the


