


The Washington State Liquor Control Board Enforcement and Education Division ("Enforcement") represented by its attorneys ROBERT W. FERGUSON, Attorney General, and SUSIE GILES-KLEIN, Assistant Attorney General, and the Licensee LOC AND SHANE, INC., d/b/a MONDO'S BEACH PUB, hereby enter into this stipulated settlement agreement for Liquor Control Board Case No. L-25,386.

I. INTRODUCTION

The Washington State Liquor Control Board, Enforcement and Education Division charged the above-named Licensee in Administrative Violation Notice ("AVN") No. 3V4220A with the following alleged violation of the Washington State Liquor Control Board rules and regulations:

On or about August 8, 2014, the above-named Licensee, or employee(s) thereof, allowed an apparently intoxicated person to consume and/or possess liquor on the licensed premises, contrary to WAC 314-16-150.

1 Enforcement and the Licensee wish to enter into a settlement agreement concerning the
2 above-referenced AVN.

3 **II. AGREEMENT OF THE PARTIES**

4 Enforcement and the Licensee agree to the following:

5 1. Enforcement and the Licensee enter into this agreement to avoid the time and
6 expense of further litigation.

7 2. The Licensee explicitly waives the right of further administrative review of all
8 matters related to the above-referenced AVN. The Licensee hereby voluntarily withdraws its
9 requests for a hearing in this matter.

10 3. This agreement constitutes the final written expression of all the terms of this
11 agreement and is a complete and exclusive statement of these terms.

12 4. The Licensee stipulates to the violation set forth above and referenced in the
13 AVN, specifically: On or about August 8, 2014, the above-named Licensee, or employee(s)
14 thereof, allowed an apparently intoxicated person to consume and/or possess liquor on the
15 licensed premises, contrary to WAC 314-16-150.

16 5. The Licensee acknowledges this is the Licensee's second violation of this type
17 within a twenty-four (24) month period, which carries a standard penalty of a seven (7) day
18 suspension of the liquor license.

19 6. In consideration of Licensee's agreement not to pursue further administrative
20 review, Enforcement agrees to reduce the penalty to a five (5) day suspension. The suspension
21 shall be in effect from 11:00am on Tuesday, May 26, 2015 to 11:00am on Sunday, May 31,
22 2015.


23 7. In the event Licensee fails to comply with the requirements of Section II,
24 Paragraph 6, the Licensee shall serve the standard penalty of a seven (7) day suspension of its
25 liquor license, the dates and times of which shall be set by the Board.

1 8. The undersigned parties declare that the terms of this Settlement Agreement are
2 completely read, wholly understood, and voluntarily accepted for the purpose of making a full
3 and final compromise and settlement of any and all claims arising from the above referenced
4 AVN.

5 9. The parties recognize that this settlement agreement is subject to approval by
6 the Board.


