STIPULATED SETTLEMENT  
AGREEMENT

The Washington State Liquor Control Board Enforcement and Education Division (Enforcement) represented by its attorneys ROBERT W. FERGUSON, Attorney General, and SUSIE GILES-KLEIN, Assistant Attorney General, and the Licensee G&M STORE CORPORATION, d/b/a STAR MINI MART & DELI, hereby enter into this stipulated settlement agreement for Liquor Control Board Case No. L-25,405.

**I. INTRODUCTION**

The Washington State Liquor Control Board, Enforcement and Education Division charged the above-named Licensee in Administrative Violation Notice (AVN) No. 3G4316A with the following alleged violation of the Washington State Liquor Control Board rules and regulations:

On or about November 12, 2014, the above-named Licensee, or employee(s) thereof, unlawfully sold, gave, or otherwise supplied liquor to a person under the age of twenty-one

1 (21) and/or permitted a person under that age to consume liquor on the licensed premises,  
2 contrary to RCW 66.44.270(1).

3 Enforcement and the Licensee wish to enter into a settlement agreement concerning the  
4 above-referenced AVN.

## 5 II. AGREEMENT OF THE PARTIES

6 Enforcement and the Licensee agree to the following:

7 1. Enforcement and the Licensee enter into this agreement to avoid the time and  
8 expense of further litigation.

9 2. The Licensee explicitly waives the right of further administrative review of all  
10 matters related to the above-referenced AVN. The Licensee hereby voluntarily withdraws its  
11 request for a hearing in this matter.

12 3. This agreement constitutes the final written expression of all the terms of this  
13 agreement and is a complete and exclusive statement of these terms.

14 4. The Licensee stipulates to the violation set forth above and referenced in the  
15 AVN, specifically: On or about November 12, 2014, the above-named Licensee, or  
16 employee(s) thereof, unlawfully sold, gave, or otherwise supplied liquor to a person under the  
17 age of twenty-one (21) and/or permitted a person under that age to consume liquor on the  
18 licensed premises, contrary to RCW 66.44.270(1).

19 5. The Licensee acknowledges this is the Licensee's first violation of this type  
20 within a twenty-four (24) month period, which carries a standard monetary penalty of five  
21 hundred dollars (\$500.00) or a five (5) day suspension of the license.

22 6. In consideration of Licensee's agreement not to pursue further administrative review,  
23 Enforcement agrees to reduce the penalty to three hundred dollars (\$300). This amount shall be  
24 paid within thirty (30) days of the date of the final order of the Board. **Payment shall be made**  
25 **no later than 4:00 p.m. on the applicable date and sent to:**

4 7. In the event the Licensee fails to make full and timely payment of the monetary  
5 penalty as required in Section II, Paragraph 6, the Licensee shall serve the standard penalty of a  
6 five (5) day suspension of its liquor license, the dates and times of which shall be set by the  
7 Board.


8 8. The undersigned parties declare that the terms of this Settlement Agreement are  
9 completely read, wholly understood, and voluntarily accepted for the purpose of making a full  
10 and final compromise and settlement of any and all claims arising from the above referenced  
11 AVN.

12 9. The parties recognize that this settlement agreement is subject to approval by  
13 the Board.




