13 The Washington State Liquor Control Board Licensing and Regulation Division
14 (“Licensing”) represented by its attorneys ROBERT W. FERGUSON, Attorney General, and
15 SUSIE GILES-KLEIN, Assistant Attorney General, and the Applicant SULLIVAN
16 SCOREBOARD, LLC d/b/a SULLIVAN SCOREBOARD (“Applicant”) represented by
17 DEANNA RECKORD, hereby enter into this stipulated settlement agreement for Liquor
18 Control Board Case No. L-25,444.

19 **I. INTRODUCTION**

20 On March 3, 2015, Licensing issued a Statement of Intent to Deny the Applicant’s
21 liquor license application no. 358078. The denial was based on the Applicant’s failure to
22 provide the necessary documents to Licensing pursuant to RCW 66.24.010(2), WAC 314-07-
23 065(2), and WAC 314-12-035(1). The Applicant appealed the denial on March 5, 2015.

24 Licensing and the Applicant wish to enter into a settlement agreement concerning the
25 above-referenced Statement of Intent to Deny.

1 **II. AGREEMENT OF THE PARTIES**

2 The parties agree to the following:

3 1. Licensing and the Applicant enter into this Settlement Agreement to avoid the
4 time and expense of further litigation.

5 2. The Applicant explicitly waives the right of further administrative review of all
6 matters related to the above-referenced Statement of Intent to Deny. The Applicant hereby
7 voluntarily withdraws its request for a hearing in this matter.

8 3. In consideration of Applicant's agreement not to pursue further administrative
9 review, Licensing shall allow Application No. 358078 to be voluntarily withdrawn. No formal
10 denial shall be issued regarding the above-referenced application.

11 4. The parties agree that the Applicant is prohibited from applying for a liquor
12 license for one year from the date of Licensing's report recommending denial. Thus, Applicant
13 shall not apply for a liquor license until after February 16, 2016.

14 5. This Settlement Agreement constitutes the final written expression of all the
15 terms of the parties' agreement, and is a complete and exclusive statement of these terms.

16 6. The undersigned parties declare that the terms of this Settlement Agreement are
17 completely read, wholly understood, and voluntarily accepted for the purpose of making a full
18 and final settlement of any and all claims arising from the above-referenced Statement of Intent
19 to Deny.




