16 ARYNA ANDERSON, Assistant Attorney General, and HEE SUNG YI and/or SUNG JU YI
17 d/b/a ALDERTON GENERAL STORE (Licensee) by and through its representative(s), HEE
18 SUNG YI and/or SUNG JU YI, and the parties having voluntarily entered into a stipulated
19 settlement agreement for case number L-25,499, and the Board having considered the Stipulated
20 Settlement Agreement and Enforcement's Memorandum recommending acceptance of the
21 Stipulated Settlement Agreement, and the Board having had the opportunity to review the file
22 materials maintained in this case, now therefore:

23 IT IS HEREBY ORDERED that the Stipulated Settlement Agreement in the above
24 captioned case is adopted in its entirety; and the AVN for case number L-25,499 is sustained.
25 The Licensee shall pay three hundred dollars (\$300.00) no later than thirty (30) days after the



9 Responsible Alcohol Sales Training Course within sixty (60) days of the date of the Final Order
10 of the Board.

18 YI and/or SUNG JU YI, hereby enter into this stipulated settlement agreement for Liquor
19 Control Board (LCB) case number L-25,499.

20 **I. INTRODUCTION**

21 The Washington State Liquor Control Board, Enforcement and Education Division
22 issued administrative violation notice (AVN) 1Q5125A to the aforementioned Licensee
23 alleging that on or about May 5, 2015, the Licensee and/or its employee gave, sold and/or
24 otherwise supplied liquor to a person under twenty-one years of age contrary to RCW
25 66.44.270(1), WAC 314-11-020(1) and WAC 314-16-150(1).

1 8. The Licensee further agrees that the Licensee and its employee(s) will complete
2 the Responsible Alcohol Sales Training Course within sixty (60) days of the date of the Final
3 Order of the Board.

4 9. The parties recognize that this settlement agreement is subject to approval by
5 the Washington State Liquor Control Board.




