FINAL ORDER OF THE BOARD

The above-captioned matter coming on regularly before the Board, and it appearing that:

1. The Licensing Division of the Liquor Control Board issued a Statement of Intent to Deny Marijuana License dated June 24, 2014 asserting that the Applicant failed to submit required documents to include valid proof of Washington residency. It was also found by Licensing staff that the Applicant's proposed location is within 475 feet of Evergreen Park in Vancouver, WA.

2. The Applicant timely submitted a request for an administrative hearing.

3. The Applicant submitted a Motion to Dismiss Hearing dated January 21, 2015.

4. On January 28, 2015, Administrative Law Judge Jeffrey A. Friedman issued an Order of Dismissal, dismissing the matter.

5. The entire record in this proceeding was presented to the Board for final decision, and the Board having fully considered said record and being fully advised in the premises;

NOW, THEREFORE, IT IS HEREBY ORDERED that the Order of Dismissal for case M-25,125 is adopted.


IT IS HEREBY FURTHER ORDERED that the Statement of Intent to Deny Marijuana License for case M-25,125 in this matter is ADOPTED.

AND IT IS HEREBY FURTHER ORDERED that marijuana retailer license application number 403998 for MAA Roselyn and Associates Inc. d/b/a 39th St Mini Mart is DENIED.

Reconsideration. Pursuant to RCW 34.05.470, you have ten (10) days from the mailing of this Order to file a petition for reconsideration stating the specific grounds on which relief is requested. A petition for reconsideration, together with any argument in support thereof, should be filed by mailing or delivering it directly to the Washington State Liquor Control Board, Attn: Kevin McCarroll, 3000 Pacific Avenue Southeast, PO Box 43076, Olympia, WA 98504-3076, with a copy to all other parties of record and their representatives. Filing means actual receipt of the document at the Board's office. RCW 34.05.010(6). A copy shall also be sent to Mary M. Tennyson, Senior Assistant Attorney General, 1125 Washington St. SE, P.O. Box 40110, Olympia, WA 98504-0110. A timely petition for reconsideration is deemed to be denied if, within twenty (20) days from the date the petition is filed, the agency does not (a) dispose of the

petition or (b) serve the parties with a written notice specifying the date by which it will act on the petition. An order denying reconsideration is not subject to judicial review. RCW 34.05.470(5). The filing of a petition for reconsideration is not a prerequisite for filing a petition for judicial review.

Stay of Effectiveness. The filing of a petition for reconsideration does not stay the effectiveness of this Order. The Board has determined not to consider a petition to stay the effectiveness of this Order. Any such request should be made in connection with a petition for judicial review under chapter 34.05 RCW and RCW 34.05.550.

Judicial Review. The applicant withdrew its request for an administrative hearing. Because there was no hearing held, no judicial review is available for this case.

Service. This Order was served on you the day it was deposited in the United States mail. RCW 34.05.010(19).


