RECONSIDERATION

The above-captioned matter coming on regularly before the Board, and it appearing that:

1. The Licensing Division of the Liquor Control Board issued an Amended Statement of Intent to Deny Marijuana License dated February 3, 2015 asserting that the Applicant's proposed location is a residence, that the proposed location is approximately 960 feet from Children's Lab School at 412 South Oak Street in Centralia, WA, that the proposed location is approximately 970 feet from George Washington Park on South Pearl Street in Centralia, WA, and that Centralia Timberland Library at 110 South Silver Street in Centralia, WA is approximately 970 feet from the proposed location.

2. A timely hearing request was received from the Applicant.

3. On March 11, 2015, Administrative Law Judge Terry. A. Schuh entered an Order Dismissing Appeal, holding that the Applicant was in default and dismissing the appeal.

4. The Board issued its Final Order dated May 12, 2015, which adopted the default order and the Statement of Intent to Deny Marijuana License and denied the Applicant's Marijuana Retailer License.


5. The Applicant timely filed a request for reconsideration on May 22, 2015.

The entire record in this proceeding was presented to the Board for final decision, and the Board having fully considered said record and being fully advised in the premises;


NOW THEREFORE; IT IS HEREBY ORDERED that the Petition for Reconsideration is DENIED.


