


STIPULATED SETTLEMENT
AGREEMENT

The Washington State Liquor Control Board Licensing and Regulation Division ("Licensing") represented by its attorneys ROBERT W. FERGUSON, Attorney General and SUSIE GILES-KLEIN, Assistant Attorney General, and the marijuana retail license applicant CADUCEUS, through its representative KIMBERLY SKILLICORN, hereby enter into this stipulated settlement agreement for Liquor Control Board Case No. M-25,182.

I. INTRODUCTION

On July 17, 2014, Licensing issued a Statement of Intent to Deny Marijuana Retailer License to Caduceus, application number 415060 ("Applicant"). The Applicant requested an administrative hearing to contest the denial. Licensing and the Applicant wish to enter into a settlement agreement concerning the above-referenced application.

1 10. If, after a thorough investigation, the Applicant's application is otherwise
2 qualified, the Board will grant the Applicant a marijuana retail license for Bellevue.

3 11. If the Applicant draws a number higher than 4, its application will not be
4 processed further unless the lower numbers become ineligible for a license due to withdrawals
5 or disqualifications.

6 12. If the Applicant draws the same number as an applicant from the original lottery
7 and that number is or becomes eligible for further processing, then both applications will be
8 processed. Licenses will be granted to both applicants if, after a thorough investigation, they
9 are otherwise qualified.

10 13. If the Applicant's application is not reached for processing before all allotted
11 licenses are granted for Bellevue, the Board will consider it withdrawn, along with other
12 applications not reached for processing.

13 14. If the Applicant is not granted a license, it may re-apply when the Board again
14 accepts retail marijuana license applications

15 15. The alternate Bellevue lottery will be conducted within 90 days after this
16 agreement is signed by counsel for the Board. The Board will promptly notify the Applicant of
17 the results, with processing to immediately follow should the Applicant draw a number
18 between 1 and 4.

19 16. The Applicant acknowledges that nothing in this agreement shall be construed
20 to entitle the Applicant to a marijuana retail license.


