1. The Liquor Control Board issued its Final Order in this case dated March 3, 2015.
2. The Applicant, through its attorney Alexander H. Thomason, filed a Petition for Reconsideration, received by the Board on March 13, 2015.
3. The Education and Enforcement Division of the Board, through Assistant Attorney General Kim O'Neal, filed a Response in Opposition to Reconsideration March 27, 2015.
4. The entire record in this proceeding was presented to the Board for final decision, and the Board having fully considered said record and being fully advised in the premises;

NOW THEREFORE; IT IS HEREBY ORDERED the Board grants the Petition for Reconsideration, solely for the purpose of correcting errors in the Final Order issued on March 3, 2015. The Final Order of the Board is AMENDED to correct a reference to the date of the Initial Order, as follows:

Paragraph 3 is modified to read: On December 16, 2014, Administrative Law Judge Joshua D. Sundt issued his Initial Order, affirming the decision to deny the Applicant's license application;

The Board modifies the Findings of Fact in the Initial Order as follows:


Finding of Fact 4.4 is modified to correct the name of the property owner. Finding of Fact No. 4 refers to "Jodi Davidson" who is an employee of the Board. The correct reference to the name of the owner of the property Mr. Ostreim planned to lease is Julie Davisson.

Finding of Fact 4.11 is modified to substitute the name of Julie Davisson for "Ms. Davidson" in the second and third sentences.

IT IS HEREBY FURTHER ORDERED that the Applicant's request for a new hearing is DENIED.


