FINAL ORDER OF THE BOARD

The above-captioned matter coming on regularly before the Board, and it appearing that:

1. The Licensing Division of the Liquor Control Board issued a Statement of Intent to Deny Marijuana License dated July 30, 2014, asserting that the Applicant failed to submit a required, valid and signed letter of intent to lease or purchase from property owner or designee.

2. The Applicant submitted a timely request for a hearing.

3. Prior to a hearing, the Applicant, through their attorney Hilary Bricken, submitted to the Office of Administrative Hearings a Notice of Voluntary Withdrawal dated May 14, 2015, withdrawing the appeal.

4. On May 18, 2015 Administrative Law Judge Terry A. Schuh with the Office of Administrative Hearings issued an Initial Order of Dismissal for withdrawal which dismissed the appeal.

5. The entire record in this proceeding was presented to the Board for final decision, and the Board having fully considered said record and being fully advised in the premises;

NOW, THEREFORE, IT IS HEREBY ORDERED that the Statement of Intent to Deny Marijuana License for case M-25,303 in this matter is ADOPTED.

IT IS HEREBY FURTHER ORDERED that marijuana retailer license application number 413388 for All Spark Inc. d/b/a All Spark is DENIED.

Reconsideration. Pursuant to RCW 34.05.470, you have ten (10) days from the mailing of this Order to file a petition for reconsideration stating the specific grounds on which relief is requested. A petition for reconsideration, together with any argument in support thereof, should be filed by mailing or delivering it directly to the Washington State Liquor Control Board, Attn: Kevin McCarroll, 3000 Pacific Avenue Southeast, PO Box 43076, Olympia, WA 98504-3076, with a copy to all other parties of record and their representatives. Filing means actual receipt of the document at the Board's office. RCW 34.05.010(6). A copy shall also be sent to Mary M. Tennyson, Senior Assistant Attorney General, 1125 Washington St. SE, P.O. Box 40110, Olympia, WA 98504-0110. A timely petition for reconsideration is deemed to be denied if, within twenty (20) days from the date the petition is filed, the agency does not (a) dispose of the petition or (b) serve the parties with a written notice specifying the date by which it will act on the petition. An order denying reconsideration is not subject to judicial review. RCW 34.05.470(5).

The filing of a petition for reconsideration is not a prerequisite for filing a petition for judicial review.

Stay of Effectiveness. The filing of a petition for reconsideration does not stay the effectiveness of this Order. The Board has determined not to consider a petition to stay the effectiveness of this Order. Any such request should be made in connection with a petition for judicial review under chapter 34.05 RCW and RCW 34.05.550.

Judicial Review. The applicant stipulated to withdraw its request for an administrative hearing. Settlement agreements are not subject to judicial review, and because there was no hearing held, no judicial review is available.

Service. This Order was served on you the day it was deposited in the United States mail. RCW 34.05.010(19).


