

1 3G4221A for Case Number L-25,334 is sustained. Licensee shall pay one hundred dollars

STIPULATED
SETTLEMENT AGREEMENT

The Washington State Liquor Control Board Education and Enforcement Division (Enforcement), by and through its attorneys, ROBERT W. FERGUSON, Attorney General, and ARYNA ANDERSON, Assistant Attorney General, and TIM SQUARED, LLC d/b/a EPULO RESTAURANT (Licensee) by and through its representative, TIMOTHY MORRIS, hereby enter into this stipulated settlement agreement for Liquor Control Board (LCB) case number L-25,334.

I. INTRODUCTION

The Washington State Liquor Control Board, Enforcement and Education Division issued administrative violation notice (AVN) 3G4221A to the Licensee and Amended Complaint alleging that between June 1, 2013 and August 9, 2014, the Licensee or its employee(s) altered its licensed premises at 526 Main Street, Edmonds, Washington, without board approval or advance authorization, contrary to WAC 314-02-130.

1 **II. AGREEMENT OF THE PARTIES**

2 Enforcement and the Licensee agree to the following:

3 1. The parties enter into this Agreement to avoid the time and expense of further
4 litigation.

5 2. The Licensee explicitly waives the right of further administrative review of all
6 matters related to the above-referenced AVN. The Licensee hereby voluntarily withdraws its
7 request for a hearing in the matters pertaining to AVN 3G4221A.

8 3. This Agreement constitutes the final written expression of all the terms of this
9 Agreement, and it is a complete and exclusive statement of these terms.

10 4. The Licensee admits to the violation set forth in AVN 3G4221A and the
11 Amended Complaint. Specifically, that between June 1, 2013 and August 9, 2014, the above-
12 named Licensee or its employee(s) altered its premises at 526 Main Street, Edmonds,
13 Washington, without board approval or advance authorization, contrary to WAC 314-02-130.

14 5. The Licensee acknowledges that the above referenced Group 2 violation is the
15 Licensee's first violation within a twenty-four (24) month period, for which the standard
16 penalty is suspension of the Licensee's liquor license for five (5) days or a monetary penalty of
17 one hundred dollars (\$100).

18 6. To settle the violation, the Licensee agrees to pay a monetary penalty of one
19 hundred dollars (\$100) for violation stipulated to in Section II, Paragraph 4 within thirty (30)
20 days of the date of the Final Order of the Board, no later than 4:00 p.m. on the applicable date.

24 7. In the event that the Licensee fails to make the full payment of the monetary
25 penalty on time, as set out and required by Section II, Paragraph 6, the Licensee shall be subject


