1. The City of Kennewick submitted a letter, dated July 16, 2014, objecting to the location on the application stating the site is within 1,000 feet of a day care named Bright Beginnings Child Care at 202 N Lincoln St, in Kennewick, WA.

2. The Licensing Division of the Liquor Control Board issued a Statement of Intent to Approve Marijuana Retail License dated November 14, 2014. The City of Kennewick was not granted a hearing in this matter.

3. The entire record in this proceeding was presented to the Board for final decision, and the Board having fully considered said record and being fully advised in the premises; NOW, THEREFORE, IT IS HEREBY ORDERED that the Statement of Intent to Approve Marijuana Retail License for case M-25,374 in this matter is ADOPTED.



Reconsideration. Pursuant to RCW 34.05.470, you have ten (10) days from the mailing of this Order to file a petition for reconsideration stating the specific grounds on which relief is requested. A petition for reconsideration, together with any argument in support thereof, should be filed by mailing or delivering it directly to the Washington State Liquor Control Board, Attn: Kevin McCarroll, 3000 Pacific Avenue Southeast, PO Box 43076, Olympia, WA 98504-3076, with a copy to all other parties of record and their representatives. Filing means actual receipt of the document at the Board's office. RCW 34.05.010(6). A copy shall also be sent to Mary M. Tennyson, Senior Assistant Attorney General, 1125 Washington St. SE, P.O. Box 40110, Olympia, WA 98504-0110. A timely petition for reconsideration is deemed to be denied if, within twenty (20) days from the date the petition is filed, the agency does not (a) dispose of the petition or (b) serve the parties with a written notice specifying the date by which it will act on the petition. An order denying reconsideration is not subject to judicial review. RCW 34.05.470(5).

The filing of a petition for reconsideration is not a prerequisite for filing a petition for judicial review.

Stay of Effectiveness. The filing of a petition for reconsideration does not stay the effectiveness of this Order. The Board has determined not to consider a petition to stay the effectiveness of this Order. Any such request should be made in connection with a petition for judicial review under chapter 34.05 RCW and RCW 34.05.550.

Judicial Review. Proceedings for judicial review may be instituted by filing a petition in superior court according to the procedures specified in chapter 34.05 RCW, Part V, Judicial Review and Civil Enforcement. The petition for judicial review of this Order shall be filed with the appropriate court and served on the Board, the Office of the Attorney General, and all parties within thirty days after service of the final order, as provided in RCW 34.05.542.



**STATEMENT OF INTENT TO  
APPROVE MARIJUANA RETAIL  
LICENSE**

The authority of the Washington State Liquor Control Board in this proceeding is based on the provisions of Title 69 Revised Code of Washington (RCW) and Title 314 Washington Administrative Code (WAC).

**1. LICENSE HISTORY**

1.1 Respondent has not held a Marijuana Retail License.

**2. SUMMARY OF RELEVANT FACTS**

- 2.1 The Mayor of Kennewick submitted a timely objection to the license approval for a Marijuana Retail License for Americanna Weed Co. The objection was based on a moratorium effective December 13, 2013. The City further objects to the license application because Bright Beginnings Child Care Center is within 1000 feet of the applicant's proposed location.
- 2.2 It was found by the Board that issues of local moratoriums are not within the Board's jurisdiction.
- 2.3 It was found by the Board that Bright Beginnings Child Care Center is licensed as a family child care home. The Department of Early Learning defines a family child care home as one that provides direct care, supervision and early learning opportunities in the provider's home. WAC 314-55-010(4) defines child care center as an entity that regularly provides child day care and early learning services for a group of children for periods of less than twenty-four hours licensed by the Washington State Department of Early Learning under chapter 170-295 WAC.

### 3. RELEVANT AUTHORITY AND CONCLUSIONS

- 3.1 Consideration of the matters outlined in paragraph 2.1 is provided under the provisions of RCW 69.50.331(7).
- 3.2 Consideration of the matter outlined in paragraphs 2.1 and 2.3 is provided under the provisions of RCW 69.50.331(8) and WAC 314-55-010(4)
- 3.3 Consideration of the matters outlined in paragraph 2.1 and 2.3 is provided under the provisions of WAC 314-55-010(4),
- 3.4 Paragraphs 3.1 through 3.2 above each establish a separate and independently sufficient basis for the decision.

### 4. REQUEST FOR APPROVAL

The below-signed Licensing and Regulation Division Director for the Washington State Liquor Control Board reviewed the following materials in making this decision:

- Report of Application prepared by MJ Investigator Lynch dated October 23, 2014
- GPS coordinates prepared by LCB staff
- Applicant's personal/criminal history statement (with attachments) dated June 21, 2014
- MJ Unit Interoffice communication regarding criminal history dated June 25, 2014
- Applicant's response to criminal history point accumulation dated July 6, 2014
- Letter to Local Authority dated July 3, 2014
- City of Kennewick's response dated July 16, 2014

Based on those materials, having concluded as set forth above, intends to approve the Marijuana Retail License of Americanna Weed Co. The Mayor of Kennewick is not granted an administrative hearing in appeal of this decision.
