

21 Liquor Control Board (LCB) case number M-25,388.

22 **I. INTRODUCTION**

23 The Washington State Liquor Control Board, Enforcement and Education Division  
24 issued Administrative Violation Notice (AVN) 714297A to the Licensee alleging that on or  
25 about October 24, 2014, the Licensee or an employee(s) thereof failed to utilize and/or  
26 maintain traceability, contrary to WAC 314.55.083(4).

STIPULATED  
SETTLEMENT AGREEMENT

1 **II. AGREEMENT OF THE PARTIES**

2 Enforcement and the Licensee agree to the following:

3 1. The parties enter into this Agreement to avoid the time and expense of further  
4 litigation.

5 2. The Licensee explicitly waives the right of further administrative review of all  
6 matters related to the above-referenced AVN. The Licensee hereby voluntarily withdraws its  
7 request for a hearing in this matter.

8 3. This Agreement constitutes the final written expression of all the terms of this  
9 Agreement, and it is a complete and exclusive statement of these terms.

10 4. The Licensee admits to the violations set forth in AVN 7I4297A. Specifically,  
11 that on or about October 24, 2014, the Licensee or an employee(s) thereof failed to utilize  
12 and/or maintain traceability, contrary to WAC 314.55.083(4).

13 5. The Licensee acknowledges that the above referenced violation is the  
14 Licensee's first violation within a three-year window, for which the standard penalty is a  
15 monetary fine of two thousand five hundred dollars (\$2,500) under WAC 314-55-535.

16 6. The Licensee agrees to voluntarily relinquish its marijuana license No. 413864  
17 and cease all operations by May 15, 2015. In consideration for the Licensee's admission,  
18 willingness to enter into this agreement, and voluntary relinquishment of its marijuana license,  
19 Enforcement agrees to waive the monetary penalty of \$2,500.


