FINAL ORDER OF THE BOARD

The above-captioned matter coming on regularly before the Board, and it appearing that:

1. The Licensing Division of the Liquor Control Board issued a Statement of Intent to Deny Marijuana License dated January 8, 2015 and March 31, 2015 asserting that the Applicant failed to meet the requirements of the 60 Day Administrative Withdrawal Notice dated September 18, 2014 and October 23, 2014.

2. The Licensing Division mailed the Statement of Intent to Deny Marijuana License dated January 8, 2014 by US Mail, Certified with Electronic Return Receipt, addressed to the applicant to the address on file with the Board, 4706 Fremont Avenue North, Seattle, WA 98103. When the Statement of Intent was returned to the Board as "undeliverable as addressed, unable to forward" on January 20, 2015, Licensing Division staff sent an email to the Applicant on January 21, 2015, asking if there was a different address to send the Statement of Intent to, and the Applicant did not respond.

3. The Licensing Division mailed a second Statement of Intent to Deny Marijuana License, dated March 31, 2015 and mailed that day, by US mail, Certified with Electronic Return Receipt. This copy of the Statement of Intent was addressed to the address of 44942 SR 20, Concrete, WA, 98237, and arrived at Concrete, Washington on April 3, 2015. This copy of the Statement of Intent was also returned to the Board "undeliverable as addressed." On April 27, 2015, Licensing Division staff sent an email to two different email addresses on file for this application, but received no response or correction to the mailing address. Because the Applicant did not respond to either the mailed Statement of Intent or the emails requesting a corrected address, no hearing request was received from the Applicant.



The entire record in this proceeding was presented to the Board for final decision, and the Board having fully considered said record and being fully advised in the premises; NOW, THEREFORE, IT IS HEREBY ORDERED that the Statement of Intent to Deny Marijuana License for case M-25,399 in this matter is ADOPTED.

IT IS HEREBY FURTHER ORDERED that license application for Marijuana Retailer for Green Easy Herbals, Inc. d/b/a Green Easy Herbals is DENIED.

Reconsideration. Pursuant to RCW 34.05.470, you have ten (10) days from the mailing of this Order to file a petition for reconsideration stating the specific grounds on which relief is requested. A petition for reconsideration, together with any argument in support thereof, should be filed by mailing or delivering it directly to the Washington State Liquor Control Board, Attn: Kevin McCarroll, 3000 Pacific Avenue Southeast, PO Box 43076, Olympia, WA 98504-3076, with a copy to all other parties of record and their representatives. Filing means actual receipt of the document at the Board's office. RCW 34.05.010(6). A copy shall also be sent to Mary M. Tennyson, Senior Assistant Attorney General, 1125 Washington St. SE, P.O. Box 40110, Olympia, WA 98504-0110. A timely petition for reconsideration is deemed to be denied if, within twenty (20) days from the date the petition is filed, the agency does not (a) dispose of the petition or (b) serve the parties with a written notice specifying the date by which it will act on the petition. An order denying reconsideration is not subject to judicial review. RCW 34.05.470(5). The filing of a petition for reconsideration is not a prerequisite for filing a petition for judicial review.

Stay of Effectiveness. The filing of a petition for reconsideration does not stay the effectiveness of this Order. The Board has determined not to consider a petition to stay the effectiveness of this Order. Any such request should be made in connection with a petition for judicial review under chapter 34.05 RCW and RCW 34.05.550.

Judicial Review. Proceedings for judicial review may be instituted by filing a petition in superior court according to the procedures specified in chapter 34.05 RCW, Part V, Judicial Review and Civil Enforcement. The petition for judicial review of this Order shall be filed with

the appropriate court and served on the Board, the Office of the Attorney General, and all parties within thirty days after service of the final order, as provided in RCW 34.05.542.


