FINAL ORDER OF THE BOARD

The above-captioned matter coming on regularly before the Board, and it appearing that:

1. The Licensing Division of the Liquor Control Board issued a Statement of Intent to Deny Marijuana License dated January 15, 2015, asserting that Applicant Alex Robert Buckingham accrued 12 criminal history points for a felony conviction for Criminal Conspiracy Manufacture; Marijuana (2011).
2. The Applicant submitted a request for a brief adjudicative proceeding.
3. On March 26, 2015, Administrative Law Judge Terry A. Schuh issued Findings of Fact, Conclusions of Law and Initial Order on Brief Adjudicative Proceeding, affirming the decision to deny the Applicant's license application as expressed in the Statement of Intent to Deny Marijuana License and remanding the matter to the Liquor Control Board for the opportunity to inquire into the purported changes in ownership structure for reconsideration.
4. No request for administrative review was received.


5. The entire record in this proceeding was presented to the Board for final decision, and the Board having fully considered said record and being fully advised in the premises;

NOW, THEREFORE, IT IS HEREBY ORDERED that the Administrative Law Judge's Findings of Fact, Conclusions of Law and Initial Order are, AFFIRMED and adopted as the Findings of Fact, Conclusions of Law and Final Order of the Board;

IT IS HEREBY FURTHER ORDERED that the Licensing Division shall review the application and process the revised application in the manner in which it would process other applications for marijuana licenses in which changes to the ownership of the applicant business are made.

Reconsideration. Pursuant to RCW 34.05.470, you have ten (10) days from the mailing of this Order to file a petition for reconsideration stating the specific grounds on which relief is requested. A petition for reconsideration, together with any argument in support thereof, should be filed by mailing or delivering it directly to the Washington State Liquor Control Board, Attn: Kevin McCarroll, 3000 Pacific Avenue Southeast, PO Box 43076, Olympia, WA 98504-3076, with a copy to all other parties of record and their representatives. Filing means actual receipt of the document at the Board's office. RCW 34.05.010(6). A copy shall also be sent to Mary M. Tennyson, Senior Assistant Attorney General, 1125 Washington St. SE, P.O. Box 40110,

Olympia, WA 98504-0110. A timely petition for reconsideration is deemed to be denied if, within twenty (20) days from the date the petition is filed, the agency does not (a) dispose of the petition or (b) serve the parties with a written notice specifying the date by which it will act on the petition. An order denying reconsideration is not subject to judicial review. RCW 34.05.470(5). The filing of a petition for reconsideration is not a prerequisite for filing a petition for judicial review.

Stay of Effectiveness. The filing of a petition for reconsideration does not stay the effectiveness of this Order. The Board has determined not to consider a petition to stay the effectiveness of this Order. Any such request should be made in connection with a petition for judicial review under chapter 34.05 RCW and RCW 34.05.550.

Judicial Review. Proceedings for judicial review may be instituted by filing a petition in superior court according to the procedures specified in chapter 34.05 RCW, Part V, Judicial Review and Civil Enforcement. The petition for judicial review of this Order shall be filed with the appropriate court and served on the Board, the Office of the Attorney General, and all parties within thirty days after service of the final order, as provided in RCW 34.05.542.



1. ISSUE PRESENTED

1.1. Whether the Liquor Control Board's decision to deny the Applicant's application for a marijuana license should be affirmed.

2. ORDER SUMMARY

2.1. The Liquor Control Board's decision to deny the Applicant's application for a marijuana license is affirmed.

2.2. However, the matter is remanded to the Liquor Control Board for the opportunity to inquire into the Applicant's change in ownership, management, and name and determine if those changes warrant reconsideration of the denial of the Applicant's application for a marijuana license.

3. HEARING

3.1. **Brief Adjudicative Proceeding:** A Brief Adjudicative Proceeding was conducted in this matter by the Administrative Law Judge, as delegated by the Liquor Control Board. The proceeding was conducted under RCW 34.05.482 through .494, Title 66 RCW, and Title 314 WAC.

3.2. **Administrative Law Judge:** Terry A. Schuh

3.3. **Applicant:** Buckingham Buds LLC dba Sweet B Buds

3.3.1. **Representative:** John Robert

3.4. **Agency:** Liquor Control Board

3.5. **Documents reviewed:** The Administrative Law Judge reviewed the marijuana licensing records as listed in the "Index of Marijuana Licensing Records for BAP" attached to the scheduling letter for this proceeding. The Administrative Law Judge also reviewed any additional documents submitted by the Applicant for this proceeding. The Applicant submitted the following documents for the brief adjudicative process: fax cover sheet with comment; cover letter to ALJ Schuh from John Robert dated March 12, 2015; Registered Agent / Officer Changes Form filed with Office of the Secretary of State; and Change in Governing People, Percentage Owned and/or Stock Unit Ownership Form filed with Department of Revenue.

4. FINDINGS OF FACT

I find the following facts by a preponderance of the evidence:

- 4.1. The Applicant, Buckingham Buds LLC dba Sweet B Buds applied for a marijuana producer tier 3 / processor license during the application window.
- 4.2. The application process required submission of the Applicant's Personal/Criminal History Statement. The Applicant is a Limited Liability Company. If an applicant is a limited liability company, the Liquor Control Board (LCB) requires members and spouses of members to each submit a Personal/Criminal History Statement. At the time of application, Alex Robert Buckingham was the managing member of Buckingham Buds LLC dba Sweet B Buds (the LLC). Mr. Buckingham had a 25% interest in the LLC.
- 4.3. Mr. Buckingham submitted the Personal/Criminal History Statement, signed on September 15, 2014.
- 4.4. On that Statement, Mr. Buckingham reported several charges, including manufacturing medical marijuana. For that offense, Mr. Buckingham reported an offense date of November 22, 2011, in Snohomish County, and he reported that the charge was dismissed on January 18, 2013. However, a report that LCB obtained from the Washington State Patrol showed that Mr. Buckingham was arrested on March 12, 2009, and charged with conspiracy to manufacture marijuana, a felony, in Snohomish County, and that he was convicted on April 9, 2011. Mr. Buckingham did not report that conviction.
- 4.5. Accordingly, LCB assigned 12 criminal history points to Mr. Buckingham.
- 4.6. On the LCB Report of Application, the manager/director wrote in relevant part: "The information [regarding the charge] was not disclosed on his criminal history and background check as a conviction. The applicant took no responsibility for his actions at the time."

- 4.7. Subsequently, LCB issued to the LLC a Statement of Intent to Deny Marijuana License dated January 15, 2015.
- 4.8. On February 11, 2015, the LLC filed with the Department of Revenue a change form that removed Mr. Buckingham as a manager and member of the LLC and changed the name of the LLC to Sweet B Buds LLC.
- 4.9. On February 17, 2015, the LLC filed with the Secretary of State a change form that substituted John Robert for Alex Buckingham as manager and registered agent and deleted Mr. Buckingham from the list of members of the LLC.

5. CONCLUSIONS OF LAW

Based upon the facts above, I make the following conclusions:

- 5.1. I have jurisdiction over the Applicant and subject matter of this proceeding under RCW 69.50.334, RCW 34.05.485(1)(c), RCW 34.12.040, chapter 34.05, WAC 314-42-120(1), and chapter 314-42 WAC.
- 5.2. When the Liquor Control Board denies a marijuana license application based upon the Applicant's criminal history, an appeal of that denial is addressed with a brief adjudicative proceeding. WAC 314-42-110. Accordingly, this appeal is appropriately resolved by a brief adjudicative proceeding.
- 5.3. The LCB may investigate and consider criminal history in determining whether to grant an applicant a license. RCW 69.50.331(1); WAC 314-55-020(3).
- 5.4. If the applicant is a limited liability company, all members must qualify for a marijuana license. WAC 314-55-035(1). In other words, the criminal history of each member is in effect attributed to the applicant limited liability company. So it is in this case.
- 5.5. An Applicant's failure to meet the criminal history standards outlined in WAC 314-55-040 constitutes a basis for the Liquor Control Board to deny a marijuana license application. WAC 314-55-050(4).
- 5.6. More specifically, a criminal history accumulating eight or more points as described in WAC 314-55-040(1) is grounds for denying a marijuana license application. WAC 314-55-040(1), (3).
- 5.7. Here, Mr. Buckingham had a felony conviction on April 9, 2011. A felony conviction within the 10 years preceding an application is assigned 12 points. WAC 314-55-040(1). So, Mr. Buckingham's criminal history points are 12.
- 5.8. However, one exception to criminal history point assignment exists that may be relevant to these circumstances: "Prior to initial license application, any single state or federal conviction for the growing, possession, or sale of marijuana will be considered for mitigation on an individual basis. Mitigation will be considered

based on the quantity of product involved *and other circumstances surrounding the conviction.*" WAC 314-55-040(3)(b) (emphasis added). Here, the LCB specifically observed that Mr. Buckingham failed to properly disclose the conviction and that he "took no responsibility for his actions at the time". Accordingly, apparently, the LCB decided not to except Mr. Buckingham's felony conviction from criminal history point assignment. Mitigation, if applied, is at the discretion of the LCB. The Administrative Law Judge has no authority to override that discretion.

5.9. Here, Mr. Buckingham exceeds the regulatory threshold for a negative criminal history and the LLC's application should be denied.

5.10. Nevertheless, the LLC took steps to insulate itself from Mr. Buckingham's negative criminal history by canceling his membership in the LLC as well as his management role, and changing the name of the LLC. However, ownership changes must be pre-approved by the LCB. WAC 314-55-120(1). The only evidence in the record that LCB pre-approved the change in ownership here was Mr. Robert's reference in his cover letter that Mr. Buckingham was removed as instructed by the LCB. Moreover, given that Mr. Buckingham was apparently instrumental in generating the LLC's application and given that he was experienced in growing marijuana, there remains a question as to the actual degree to which Mr. Buckingham's relationship with the LLC has changed. Further, and more to the point: "The [LCB] may inquire into all matters in connection with any . . . proposed change in officers/members." WAC 314-55-120(2). There is no evidence in the record that LCB had the opportunity to make any such inquiry. Thus, this matter should be remanded to the LCB for the opportunity to make such inquiry.

5.11. Accordingly, in sum, the LCB's denial of the LLC's application should be affirmed but the matter remanded to the LCB for the opportunity to inquire into change in ownership and management of the LLC.

6. INITIAL ORDER

IT IS HEREBY ORDERED THAT:

6.1. The Liquor Control Board's decision to deny the Applicant's application for a marijuana producer tier 3 / processor license is **AFFIRMED**.

6.2. The Applicant's application for a marijuana producer tier 3 / processor license is denied.

6.3. This matter is **REMANDED** to the Liquor Control Board for the opportunity to inquire into the change in ownership, management, and name of the Applicant, Buckingham Buds LLC dba Sweet B Buds and to determine if the nature and timing of those changes causes the Liquor Control Board to reconsider its decision to

deny the Applicant's application for a marijuana producer tier 3 / processor license.
