FINAL ORDER OF THE BOARD

The above-captioned matter coming on regularly before the Board, and it appearing that:

1. The Licensing Division of the Liquor Control Board issued an Amended Statement of Intent to Approve Marijuana License on January 15, 2015. Based on information available at the time, the Board issued Final Order M-25,402 on January 27, 2015 approving the Statement of Intent to Approve Marijuana License and granting a marijuana license to the above-captioned Applicant over the objection of the City of Mercer Island and its contention that North Mercerdale Hillside Park meets the definition of a park. The Final Order was appealed by Mercer Island in Superior Court and the license was not issued. Additional information was provided to the Licensing Division on January 20, 2015 citing Aubrey Davis Park as being

less than 1,000 feet from the applicant's proposed location. Licensing then issued a Statement of Intent to Deny Marijuana License on March 11, 2015 stating that Aubrey Davis Park at 72nd Avenue SE and SE 22nd Street on Mercer Island, Washington is located within 830 feet of the Applicant's proposed location at 7513 SE 27th Street, Ste A, on Mercer Island, Washington.

2. No hearing request was received from the Applicant.


3. The entire record in this proceeding was presented to the Board for final decision, and the Board having fully considered said record and being fully advised in the premises; NOW, THEREFORE, IT IS HEREBY ORDERED that the Statement of Intent to Deny Marijuana License for case M-25,448 in this matter is ADOPTED.

IT IS HEREBY FURTHER ORDERED that the license application for Marijuana Retailer for Tom's Stuff LLC d/b/a Tom's Stuff Market is DENIED.

with a copy to all other parties of record and their representatives. Filing means actual receipt of the document at the Board's office. RCW 34.05.010(6). A copy shall also be sent to Mary M. Tennyson, Senior Assistant Attorney General, 1125 Washington St. SE, P.O. Box 40110, Olympia, WA 98504-0110. A timely petition for reconsideration is deemed to be denied if, within twenty (20) days from the date the petition is filed, the agency does not (a) dispose of the petition or (b) serve the parties with a written notice specifying the date by which it will act on the petition. An order denying reconsideration is not subject to judicial review. RCW 34.05.470(5). The filing of a petition for reconsideration is not a prerequisite for filing a petition for judicial review.

Stay of Effectiveness. The filing of a petition for reconsideration does not stay the effectiveness of this Order. The Board has determined not to consider a petition to stay the effectiveness of this Order. Any such request should be made in connection with a petition for judicial review under chapter 34.05 RCW and RCW 34.05.550.

Judicial Review. Proceedings for judicial review may be instituted by filing a petition in superior court according to the procedures specified in chapter 34.05 RCW, Part V, Judicial Review and Civil Enforcement. The petition for judicial review of this Order shall be filed with the appropriate court and served on the Board, the Office of the Attorney General, and all parties within thirty days after service of the final order, as provided in RCW 34.05.542.


