The above-captioned matter coming on regularly before the Board, and it appearing that:

1. The Board issued the following Complaints:
  - a. On October 26, 2015, the Board issued a Complaint alleging that on or about May 15, 2015, the above-named Licensee and/or employees of the licensee sold usable marijuana to a person under twenty-one years of age on the premises of the licensed retail outlet in violation of WAC 314-55-079;
  - b. On October 26, 2015, the Board issued a Complaint alleging that on or about May 15, 2015, the above-named Licensee and/or employees of the licensee allowed a person under twenty-one years of age to enter or remain on the premises of the licensed retail outlet in violation of RCW 69.50.357(2);

c. On April 14, 2016, the Board issued a Complaint alleging that on or about June 26, 2015, the above-named Licensee and/or employees of the licensee sold marijuana to a person under twenty-one years of age in violation of WAC 314-55-079;

d. On April 14, 2016, the Board issued a Complaint alleging that on or about June 26, 2015, the above-named Licensee and/or employees of the licensee allowed a person under twenty-one years of age to enter or remain on the premises of the licensed retail outlet in violation of RCW 69.50.357(2).

2. The Licensee submitted a timely requests for an administrative hearing.

3. Enforcement and the Licensee have entered into a Stipulated Settlement Agreement.

4. The entire record in this proceeding was presented to the Board for final decision, and the Board having fully considered said record and being fully advised in the premises; NOW THEREFORE; IT IS HEREBY ORDERED that the Stipulated Settlement Agreement in the above-referenced matter is adopted in its entirety.

IT IS HEREBY FURTHER ORDERED that the Licensee shall pay the monetary penalty of twenty five hundred (\$2,500) within 30 days of this order. Additionally, a 30-day suspension shall take place from 10:00 a.m. on Thursday, December 1, 2016 until 10:00 a.m. on Saturday, December 31, 2016.

If payment is not submitted timely, then an addition 10-day suspension will take place from 10:00 a.m. on Saturday, December 31, 2016 until 10:00 a.m. on Tuesday, January 10, 2017.

Failure to comply with the terms of this order will result in further disciplinary action.





STIPULATED SETTLEMENT  
AGREEMENT

7  
8 The Washington State Liquor and Cannabis Board Enforcement and Education Division  
9 ("Enforcement") represented by its attorneys Robert Ferguson, Attorney General and Kim  
10 O'Neal, Assistant Attorney General and the Licensee, Purple Haze ("Licensee"), represented by  
11 Michael Chin, hereby enter into this stipulated settlement agreement for Liquor and Cannabis  
12 Board Case Numbers M-25,732; M-25,733; M-25,763; M-25,764.

13 **I. INTRODUCTION**

14 The Washington State Liquor and Cannabis Board charged the above-named Licensee in  
15 its Complaints dated October, 2015, and April, 2016, with the following violations of the  
16 Marijuana Laws and Regulations:

17 On or about May 15, 2015, the Licensee and/or employee(s) thereof permitted a person  
18 under twenty-one years of age to enter and/or remain on the premises of the licensed retail outlet  
19 in violation of RCW 69.50.357(2).

20 On or about May 15, 2015, the Licensee and/or employee(s) thereof sold usable  
21 marijuana to a person under twenty-one years of age on the premises of the licensed retail outlet  
22 in violation of WAC 314-55-079.

23 On or about June 25, 2015, the above-named Licensee and/or employee(s) thereof  
24 allowed a person under twenty-one years of age to enter or remain on the premises of the licensed  
25 retail outlet in violation of RCW 69.50.357(2).  
26

1 On or about June 25, 2015, the above-named Licensee and/or employee(s) thereof sold  
2 usable marijuana to a person under twenty-one years of age on the premises of the licensed retail  
3 outlet in violation of WAC 314-55-079.

4 Enforcement and the Licensee wish to enter into a settlement agreement concerning the  
5 above-referenced Complaint.

## 6 II. AGREEMENT OF THE PARTIES

7 Enforcement and the Licensee agree to the following:

8 1. Enforcement and the Licensee enter into this agreement to avoid the time and  
9 expense of further litigation. The Licensee explicitly waives the right of further administrative  
10 review of all matters related to this violation. The Licensee hereby voluntarily withdraws its  
11 request for a hearing on all four of these matters.

12 2. The Licensee admits to the violations set forth in the above-referenced Complaint  
13 for case numbers M-25,732 and M-25,763. On May 15, 2015, the Licensee and/or employee(s)  
14 thereof sold usable marijuana to a person under twenty-one years of age in violation of WAC  
15 314-55-079, and on June 26, 2015, the Licensee and/or employee(s) thereof sold usable  
16 marijuana to a person under twenty-one years of age in violation of WAC 314-55-079.

17 3. The parties agree that case number M-25,732 is a first violation for selling  
18 marijuana to a person under twenty-one years of age and the standard penalty is a \$2,500  
19 monetary option or a 10-day suspension. The parties agree that the Licensee will pay the \$2,500  
20 monetary penalty for this violation.


21 3. The parties agree that case number M-25,763 is a second violation for selling  
22 marijuana to a person under twenty-one years of age, and the standard penalty is a 30-day  
23 suspension of the Licensee's retail marijuana license. The parties agree that the Licensee will  
24 serve the 30-day suspension on dates agreed upon between the Licensee and Captain Tom Dixon,  
25 to be set within two weeks of the signing of this agreement.


1 4. The State of Washington, through their counsel, hereby agrees to dismiss the  
2 violations against the licensee pursuant to RCW 69.50.357 (2) respectively occurring on May  
3 15, 2015 and June 25, 2015.


4 5. The parties recognize that this settlement agreement is subject to approval by the
