The Washington State Liquor Control Board Education and Enforcement Division (Enforcement), by and through its attorneys, ROBERT M. MCKENNA, Attorney General and RUTH AMMONS, Assistant Attorney General, and 7-ELEVEN STORE #2362-27612B, represented by ROBERT RANSLAM (Licensee), hereby enter into this stipulated settlement agreement for case number T-487, based on AVN No. 23466.

I. INTRODUCTION

On April 10, 2008, the Board filed a Complaint, based on Notice of Board Action on Tobacco Violation (AVN) No. 23466, alleging that on or about December 28, 2007, the Licensee, or employee(s) thereof, sold or permitted to be sold a tobacco product to a person under the age of 18, contrary to RCW 26.28.080 and WAC 314-10-050.

Prior to a hearing in this matter, Enforcement and the Licensee have agreed to enter into the following settlement concerning the above-referenced Complaint. Enforcement and the Licensee agree to the following:
