The above-titled matter having come before the Washington State Liquor Control Board (Board) upon a Stipulated Settlement Agreement between the Enforcement Division of the Washington State Liquor Control Board and the Licensee, Sonja Kifer d/b/a Seven Star Market, and the Board having reviewed the Stipulated Settlement Agreement:

IT IS HEREBY ORDERED that the Complaint filed in Liquor Control Board Case No. T-496 is sustained and the Stipulated Settlement Agreement for Case No. T-496 is approved, adopted in its entirety and incorporated by reference herein.


Accordingly, the Licensee shall serve a six (6) month suspension of its license to sell Tobacco products. The suspension is to begin at 2:00 p.m. on January 15th, 2009 and to end at 2:00 p.m. on July 15th, 2009. Furthermore, the licensee shall pay a one thousand dollar (\$1000) penalty in two payments of five hundred dollars (\$500) each. The first five hundred dollar (\$500) payment is to be made within thirty (30) days of the date of the Final Order of the Board. The second payment of five hundred dollars (\$500) is to be made within ninety (90) days of the date of the Final Order of the Board.

The Washington State Liquor Control Board Education and Enforcement Division (Enforcement), by and through its attorneys, ROBERT M. MCKENNA, Attorney General and GORDON KARG, Assistant Attorney General and the Licensee, SONJA KIFER, d.b.a. SEVEN STAR MARKET (Licensee), represented by PEYMAN YOUNESI, Attorney for Licensee, hereby enter into this stipulated settlement agreement for case number T-496.

I. INTRODUCTION

The Washington State Liquor Control Board issued a complaint on June 18, 2008, alleging that on or about March 28, 2008, the above-named Licensee, or employee(s) thereof, supplied tobacco to a person less than 18 years of age contrary to RCW 26.28.080.

1 **II. AGREEMENT OF THE PARTIES**

2 Prior to the scheduled administrative hearing in this matter, Enforcement and the
3 Licensee have agreed to enter into the following stipulated settlement agreement concerning
4 the above-referenced case. Enforcement and the Licensee agree to the following:

5 1. Enforcement and the Licensee enter into this agreement to avoid the time and
6 expense of further litigation.

7 2. The Licensee explicitly waives the right of further administrative review of all
8 matters related to the above-referenced case. Furthermore, the Licensee hereby voluntarily
9 withdraws its request for a hearing on this matter.

10 3. This Agreement constitutes the final written expression of all the terms of this
11 agreement and is a complete and exclusive statement of these terms.

12 4. The Licensee admits to the violation set forth in the above-referenced case.
13 Specifically, that on or about March 28, 2008, the above-named Licensee supplied tobacco
14 products to a person less than 18 years of age contrary to RCW 26.28.080.

15 5. The Licensee agrees to a six (6) month suspension of its license to sell Tobacco
16 products. The suspension is to begin at 2:00PM on January 15th, 2009 and to end on 2:00PM
17 on July 15th, 2009.


18 6. The Licensee agrees to pay a monetary penalty of one thousand dollars (\$1000).

19 7. The licensee agrees to pay the one thousand dollar (\$1000) penalty in two
20 payments of five hundred dollars (\$500) each. The first five hundred dollar (\$500) payment is
21 to be made within thirty (30) days of the date of the Final Order of the Board. The second
22 payment of five hundred dollars (\$500) is to be made within ninety (90) days of the date of the


