
THIS MATTER having come before the Washington State Liquor Control Board (Board) and the Washington State Liquor Control Board Education and Enforcement Division (Enforcement) represented by its attorneys, ROBERT M. MCKENNA, Attorney General, and TIMOTHY D. FORD, Assistant Attorney General, and the Licensee, MARK L. HUNTER, d/b/a GOOD GUYS, PDQ (Licensee), and the Board having considered the Stipulated Settlement Agreement and Enforcement's memorandum recommending acceptance of the Settlement Agreement, and the Board having had the opportunity to review the file materials maintained in this case, now therefore:

IT IS HEREBY ORDERED the Board accepts, adopts, and incorporates herein by reference the Stipulated Settlement Agreement between Enforcement and the Licensee in the above-captioned matter and further that the violation set forth and charged in the Complaint for LCB Case No. T-527 dated October 6, 2010, issued by the Board in the above-captioned matter is sustained and the Licensee shall pay a total monetary penalty of one hundred twenty

1 dollars (\$120) for the above-referenced violation. It shall further be ordered that the  
2 Licensee's previous overpayment of \$180, as set forth in the stipulated settlement agreement,  
3 shall satisfy the monetary penalty for both this LCB Case No. T-527 and for TVN 5N0264D,  
4 with no further payment due from the Licensee in this matter.

The Washington State Liquor Control Board Education and Enforcement Division (Enforcement) represented by its attorneys, ROBERT M. MCKENNA, Attorney General, and TIMOTHY D. FORD, Assistant Attorney General, and the Licensee, MARK HUNTER d/b/a GOOD GUYS, PDQ, hereby enter into this stipulated settlement agreement for Liquor Control Board Case Number T-527.

**I. INTRODUCTION**

1. The Enforcement Division issued Tobacco Violation Notice (TVN) No. 32214/4K0181F to the above-named Licensee alleging that on or about June 30, 2010, an employee for the Licensee sold/supplied tobacco to a person under the age of eighteen (18), contrary to RCW 26.28.080 and is therefore subject to the penalties set out in RCW 70.155.100.



1 time and expense of issuing a refund in TVN 5N0264D, the Licensee's previous payment of  
2 one hundred eighty dollars (\$180) shall satisfy the monetary penalties assessed in both  
3 TVN 32214/4K0181F and TVN 5N0264D, with no further payment due from the Licensee.

4 7. This agreement constitutes the final written expression of all the terms of this  
5 agreement and is a complete and exclusive statement of these terms. The undersigned parties  
6 declare that the terms of this agreement are completely read, wholly understood, and  
7 voluntarily accepted for the purpose of making a full and final compromise and settlement of  
8 any and all violations arising from the above-referenced TVN.

9 8. The parties recognize that this agreement is subject to approval by the  
10 Washington State Liquor Control Board.


