FINAL ORDER OF THE BOARD

15 THIS MATTER having come before the Washington State Liquor Control Board  
16 (Board) and the Washington State Liquor Control Board Education and Enforcement Division  
17 having been represented by its attorneys, ROBERT M. MCKENNA, Attorney General and  
18 RUTH AMMONS, Assistant Attorney General and the Licensee MKS CHIMA CORP. d/b/a  
19 AL & ERNIE'S FOODLINER having been represented by PRITAM CHIMA (Licensee), and  
20 the parties having voluntarily entered into a stipulated settlement agreement for case number  
21 T-481, and the Board having considered the stipulated settlement agreement and the file  
22 materials maintained in this case, now therefore

23 IT IS HEREBY ORDERED that the violation set forth in the Board's Complaint dated  
24 dated September 26, 2007, is sustained and within 30 days of the date of this Order, the  
25 Licensee shall pay a monetary penalty of five hundred dollars (\$500.00) to: Washington State  
26 Liquor Control Board, 12501 NE 99<sup>th</sup> St, Suite A-100, Vancouver, WA 98682. Additionally,

1 the Licensee shall be suspended from the sale of tobacco products for a period of three (3)  
2 months, from December 10, 2007, through March 10, 2007<sup>8</sup>. In the  
3 event that the Licensee does not make a full and timely payment of the monetary penalty, then  
4 the Licensee shall pay the original standard penalty of one thousand dollars (\$1,000) and shall  
5 serve a six (6) month suspension.

STIPULATED SETTLEMENT  
AGREEMENT

The Washington State Liquor Control Board Education and Enforcement Division (Enforcement), by and through its attorneys, ROBERT M. MCKENNA, Attorney General and RUTH AMMONS, Assistant Attorney General and the Licensee MKS CHIMA CORP. d/b/a AL & ERNIE'S FOODLINER, represented by PRITAM CHIMA (Licensee), hereby enter into this stipulated settlement agreement for case number T-480.

**I. INTRODUCTION**

The Washington State Liquor Control Board charged the above-named Licensee in its Complaint dated September 26, 2007, with the following violation of the Revised Code of Washington and Revised Rules and Regulations of the Board:

That on or about July 10, 2007 the above-named Licensee, or employee thereof, sold or permitted to be sold a tobacco product to a person under the age of 18, contrary to RCW 26.28.080 and WAC 314-10-050.


