





The Washington State Liquor Control Board Education and Enforcement Division (Enforcement), by and through its attorneys, ROBERT M. MCKENNA, Attorney General and GORDON KARG, Assistant Attorney General and the Licensee EXPRESS STOP, INC., d.b.a. EXPRESS STOP, represented by MOHAMMAD YOUSSEFI (Licensee), hereby enter into this stipulated settlement agreement for case number T-484.

**I. INTRODUCTION**

The Washington State Liquor Control Board issued Notice of Board Action on Tobacco Violation, alleging that on or about October 12, 2007, the above-named Licensee sold tobacco products to a person under the age of 18, contrary to RCW 26.28.080.

**II. AGREEMENT OF THE PARTIES**

Prior to the filing of an administrative complaint in this matter, Enforcement and the Licensee have agreed to enter into the following settlement concerning the above-referenced case. Enforcement and the Licensee agree to the following:

- 1. Enforcement and the Licensee enter into this agreement to avoid the time and expense of further litigation.

1           2.     The Licensee explicitly waives the right of further administrative review of all  
2 matters related to the above-referenced case. Furthermore, the Licensee hereby voluntarily  
3 withdraws its request for a hearing on this matter.

4           3.     This Agreement constitutes the final written expression of all the terms of this  
5 agreement and is a complete and exclusive statement of these terms.

6           4.     The Licensee admits to the violation set forth in the above-referenced case. On  
7 or about October 12, 2007, the above-named Licensee sold tobacco products to a person under  
8 the age of 18, contrary to RCW 26.28.080.


9           5.     The Licensee agrees to pay a monetary penalty of seventy-five dollars (\$75)


14           In the event that the Licensee does not make a full and timely payment of the monetary
