

MAHONEY, owner, and the parties having voluntarily entered into a stipulated settlement agreement for case number T-495, and Board having considered the stipulated settlement agreement, Enforcement's Memorandum recommending acceptance of the stipulated settlement agreement, Enforcement's Memorandum recommending a Revised Proposed Final Order, and the Board having had the opportunity to review the file materials maintained in this case, now therefore:

STIPULATED SETTLEMENT  
AGREEMENT

The Washington State Liquor Control Board Education and Enforcement Division (Enforcement), by and through its attorneys, ROBERT M. MCKENNA, Attorney General and BRIAN J. CONSIDINE, Assistant Attorney General and the Licensee, OPULENT SALES, LLC d/b/a AM/PM GAS STATION (Licensee), represented by JOHN R. MAHONEY, owner, hereby enter into this stipulated settlement agreement for case number T-495.

**I. INTRODUCTION**

The Washington State Liquor Control Board Enforcement Division issued to the Licensee AVN No. 20017, alleging that on or about March 18, 2008, the above-named Licensee or employee thereof, sold or permitted to be sold a tobacco product to a person under the age of 18, contrary to RCW 26.28.080 and WAC 314-10-050.

1 **II. AGREEMENT OF THE PARTIES**

2 Prior to the filing of an administrative complaint, Enforcement and the Licensee have  
3 agreed to resolve AVN No. 20018 via settlement. Enforcement and the Licensee agree to the  
4 following:

5 1. The parties enter into this agreement to avoid the time and expense of further  
6 litigation.

7 2. The Licensee explicitly waives the right of further administrative review of all  
8 matters related to the above-referenced case and AVN. Furthermore, the Licensee hereby  
9 voluntarily withdraws his request for a hearing in this matter.

10 3. This Agreement constitutes the final written expression of all the terms of this  
11 Agreement, and it is a complete and exclusive statement of these terms.

12 4. The Licensee admits to the violation set forth in AVN No. 20018. Specifically,  
13 on or about March 18, 2008, an employee of the Licensee sold a tobacco product to a person  
14 under the age of 18, in violation of RCW 26.28.080 and WAC 314-10-050.

15 5. The Licensee agrees to pay the standard monetary penalty of three hundred  
16 dollars (\$300.00) within 30 days of the date of the Final Order of the Board. Payment shall be


