


STIPULATED SETTLEMENT
AGREEMENT

The Washington State Liquor Control Board Education and Enforcement Division (Enforcement), by and through its attorneys, ROBERT M. MCKENNA, Attorney General and BRIAN J. CONSIDINE, Assistant Attorney General and the Licensee, FRANKIE W. SCHARRS d/b/a FRANKIE'S SPORTS BAR GRILL & LOUNGE, represented by SHAWN T. NEWMAN (Attorney for Licensee), hereby enter into this stipulated settlement agreement for case number T-499.

I. INTRODUCTION

The Washington State Liquor Control Board Enforcement Division issued to the Licensee AVN No. 20020, alleging that on or about May 19, 2008, the above-named Licensee or employee thereof, sold or permitted to be sold a tobacco product to a person under the age of 18, contrary to RCW 26.28.080 and WAC 314-10-050.

1 **II. AGREEMENT OF THE PARTIES**

2 Prior to the filing of an administrative complaint, Enforcement and the Licensee have
3 agreed to resolve AVN No. 20020 via settlement. Enforcement and the Licensee agree to the
4 following:

5 1. The parties enter into this agreement to avoid the time and expense of further
6 litigation.

7 2. The Licensee explicitly waives the right of further administrative review of all
8 matters related to the above-referenced case and AVN. Furthermore, the Licensee hereby
9 voluntarily withdraws his request for a hearing in this matter.

10 3. This Agreement constitutes the final written expression of all the terms of this
11 Agreement, and it is a complete and exclusive statement of these terms.

12 4. The Licensee admits to the violation set forth in AVN No. 20020. Specifically,
13 on or about May 19, 2008, an employee of the Licensee sold a tobacco product to a person
14 under the age of 18, in violation of RCW 26.28.080 and WAC 314-10-050.

15 5. The Licensee agrees to pay a monetary penalty of ^{fifty}~~seventy-five~~ dollars (\$50.00)
16 within 30 days of the date of the Final Order of the Board. Payment shall be sent to:

19 6. In the event that the Licensee does not timely satisfy the penalty set forth in
20 Section II, Paragraph 5, then the Licensee shall pay the original standard penalty of one


