

STIPULATED SETTLEMENT
AGREEMENT

The Washington State Liquor Control Board Education and Enforcement Division (Enforcement) represented by its attorneys ROBERT M. MCKENNA, Attorney General, and CINDY EVANS, Assistant Attorney General, and the Licensee, DOMINIC'S INC., d/b/a DOMINIC'S RED APPLE MARKET (Licensee) through its representative JARNAIL SINGH, hereby enter into this stipulated settlement agreement for Liquor Control Board Case T-523.

I. INTRODUCTION

1. On November 4, 2010, the Washington State Liquor Control Board issued a Complaint alleging that:

On or about July 6, 2010, the above-named Licensee, and/or employee(s) thereof, sold, or permitted to be sold, a tobacco product to a person under the age of 18 years, contrary to RCW 26.28.080.

2. Enforcement and the Licensee wish to enter into a settlement agreement concerning the above-referenced Complaint.

1 **II. AGREEMENT OF THE PARTIES**

2 Enforcement and the Licensee agree to the following:

3 1. Enforcement and the Licensee enter into this agreement to avoid the time and
4 expense of further litigation. The Licensee explicitly waives the right of further administrative
5 review of all matters related to this violation. The Licensee hereby voluntarily withdraws its
6 request for a hearing on this matter.

7 2. The Licensee admits to the violations in the above-referenced Complaint, that
8 is, on or about July 6, 2010 the above-named Licensee, or an employee(s) thereof, sold, or
9 permitted to be sold, a tobacco product to a person under the age of 18 years, contrary to
10 RCW 26.28.080.

11 3. The parties agree that the standard penalty for a first violation within a two year
12 period for selling, giving, or otherwise supplying tobacco to a person under eighteen (18) years
13 of age is a one hundred dollar (\$100) monetary penalty, pursuant to RCW 70.155.100.

14 4. The parties agree that the penalty for the above-mentioned Complaint shall be a
15 sixty dollar (\$60.00) monetary penalty.

16 5. The Licensee shall pay the monetary penalty of sixty dollars (\$60.00) no later
17 than thirty (30) days after the date of the Final Order of the Board. Payment shall be sent to:

21 6. If the Licensee subsequently fails to make a full and timely payment of the
22 penalty as required in Section II, Paragraph 4 then the standard penalty of a one hundred dollar
23 (\$100.00) penalty shall be imposed.

24 7. The parties recognize that this settlement agreement is subject to approval by
25 the Washington State Liquor Control Board.




