I. INTRODUCTION

1. The Washington State Liquor Control Board Education and Enforcement Division issued an Administrative Violation Notice No. 30210 / 2B0310B ("AVN") on November 17, 2010, to the above-named Licensee specifying the following violation of the Washington State Liquor Act:

On or about November 6, 2010, the above-named Licensee, and/or employee(s) thereof, sold, or permitted to be sold, a tobacco product to a person under the age of 18 years, contrary to RCW 26.28.080.

1 8. This agreement constitutes the final written expression of all the terms of this
2 agreement and is a complete and exclusive statement of these terms.


