15 THIS MATTER having come before the Washington State Liquor Control Board  
16 (Board) and the Washington State Liquor Control Board Education and Enforcement Division  
17 (Enforcement) by and through its attorneys, ROBERT M. MCKENNA, Attorney General, and  
18 MARISA E. BROGGEL, Assistant Attorney General, and the Licensee, GRACE NW  
19 ENTERPRISES, INC. d/b/a FIVE CORNERS GAS & GROCERY (Licensee) by and through  
20 its representative PAUL SINGH, and the parties having voluntarily entered into a Stipulated  
21 Settlement Agreement for Administrative Violation Notice (AVN) No. 1J2010A, and the  
22 Board having considered the Stipulated Settlement Agreement and Enforcement's  
23 Memorandum recommending acceptance of the Stipulated Settlement Agreement, and the  
24 Board having had the opportunity to review the file materials maintained in this case, now  
25 therefore:

1 IT IS HEREBY ORDERED that the violation set forth in AVN No. 1J2010A, to wit:  
2 the Licensee or an employee(s) thereof sold, gave, or permitted to be sold or given, a tobacco  
3 product to a person under the age of 18 years, is sustained.

4 IT IS FURTHER ORDERED that the Licensee shall pay a total monetary penalty of  
5 two hundred twenty-five dollars (\$225) for the above-referenced violation. The Licensee shall  
6 pay the monetary penalty within thirty (30) days of the date of the Final Order of the Board.

12 IT IS FURTHER ORDERED that within thirty (30) days of the date of the Final Order  
13 of the Board, the Licensee and all of its employees will participate in Responsible Liquor and  
14 Tobacco Sales Training through Enforcement.

15 In the event the Licensee fails to pay the total monetary penalty of two hundred twenty-  
16 five dollars (\$225) within thirty (30) days of the date of this Order, and/or in the event that the  
17 Licensee fails to participate in the above-referenced Responsible Liquor and Tobacco Sales  
18 Training within thirty (30) days of the date of this Order, the Licensee shall pay a monetary  
19 penalty of three hundred dollars (\$300).

The Washington State Liquor Control Board Education and Enforcement Division (Enforcement) by and through its attorneys ROBERT M. MCKENNA, Attorney General, and MARISA E. BROGGEL, Assistant Attorney General, and the Licensee, GRACE NW ENTERPRISES, INC. d/b/a FIVE CORNERS GAS & GROCERY (Licensee) by and through its representative PAUL SINGH, hereby enter into this stipulated settlement agreement for Liquor Control Board Case T-558.

**I. INTRODUCTION**

1. The Washington State Liquor Control Board Education and Enforcement Division (Enforcement) issued Administrative Violation Notice (AVN) No. 1J2010A to the above-named Licensee, specifying the following violation of the Washington State Liquor Board rules and regulations:

ORIGINAL

1 That on or around January 10, 2012, the above-named Licensee and/or  
2 employee(s) thereof sold, gave, or permitted to be sold or given, a tobacco  
product to a person under the age of eighteen (18), contrary to RCW 26.28.080.

3 2. Prior to scheduling a formal administrative hearing, Enforcement and the  
4 Licensee have agreed to enter into a settlement agreement concerning the above-referenced  
5 AVN.

6  
7 **II. AGREEMENT OF THE PARTIES**

8 Enforcement and the Licensee agree to the following:

9 1. Enforcement and the Licensee enter into this agreement to avoid the time and  
10 expense of further litigation.

11 2. The Licensee explicitly waives the right to further administrative review of all  
12 matters related to this violation and the Licensee hereby voluntarily withdraws its request for a  
13 hearing on this matter.

14 3. The Licensee admits to the violation in the above-referenced AVN; that is, on or  
15 around January 10, 2012, the above-named Licensee, or an employee(s) thereof, sold, gave, or  
16 permitted to be sold or given, a tobacco product to a person under the age of 18 years, contrary  
17 to RCW 26.28.080.

18 4. The Licensee acknowledges that the above-referenced AVN is the Licensee's  
19 second violation within a two-year period for selling, giving, or permitting to be sold or given,  
20 a tobacco product to a person under eighteen (18) years of age; further, the Licensee  
21 acknowledges that the standard penalty for a second violation within a two-year period for  
22 selling, giving, or permitting to be sold or given, a tobacco product to a person under  
23

1 | eighteen (18) years of age, is a three hundred dollar (\$300) monetary penalty, pursuant to  
2 | RCW 70.155.100.

3 |           5.       The Licensee agrees to pay a total monetary penalty of two hundred twenty-five  
4 | dollars (\$225) for the above-referenced violation. This amount shall be paid within thirty (30)  
5 | days of the date of the final order of the Washington State Liquor Control Board (Board) and  
6 | no later than 4:00 p.m. on the applicable date. Payment shall be sent to:

12 |           6.       The Licensee further agrees that within thirty (30) days of the date of the Final  
13 | Order of the Board, all of the Licensee's employees will participate in a Responsible Liquor  
14 | Sales training class through Enforcement. The Licensee is responsible for coordinating the  
15 | date, time and location of the training class through its assigned Liquor Enforcement Officer.

16 |           7.       The Licensee acknowledges that failure to make a full and timely payment of  
17 | the penalty as required in Section II, Paragraph 5, and/or failure to participate in a training  
18 | class through Enforcement as required in Section II, Paragraph 6, will result in imposition of  
19 | the standard penalty of three hundred dollars (\$300).

20 |           8.       The parties recognize that this settlement agreement is subject to approval by  
21 | the Board.


