15 (Enforcement) by and through its attorneys, ROBERT M. MCKENNA, Attorney General, and

18 having voluntarily entered into a stipulated settlement agreement for case number T-559, and  
19 the Board having considered the stipulated settlement agreement and Enforcement's  
20 Memorandum recommending acceptance of the stipulated settlement agreement, and the Board  
21 having had the opportunity to review the file materials maintained in this case, now therefore:


22 IT IS HEREBY ORDERED that the TVN for Case Number T-559 is sustained and the  
23 Licensee shall pay a monetary penalty of eighty dollars (\$80.00) no later than thirty (30) days

STIPULATED SETTLEMENT  
AGREEMENT

The Washington State Liquor Control Board Education and Enforcement Division (Enforcement) represented by its attorneys ROBERT M. MCKENNA, Attorney General and TIMOTHY D. FORD, Assistant Attorney General, and the Licensee AWNNO DATA LLC d/b/a RENTON DUVALL AM/PM, represented by PARAMITA BASU, hereby enter into this stipulated settlement agreement for Liquor Control Board Case No. T-559, arising from Tobacco Violation Notice (TVN) No. 34347.

**I. INTRODUCTION**

The Washington State Liquor Control Board Enforcement Division issued to the Licensee TVN No. 34347, License Case No. 2M2031A, alleging that on or about January 31, 2012, the above-named Licensee or employee thereof, sold or permitted to be sold a tobacco product to a person under the age of 18, contrary to RCW 26.28.080. The TVN

1 shows a two (2) year violation history and is cited as the first violation of its kind which  
2 reflects a penalty of one hundred (\$100) dollars.

### 3 II. AGREEMENT OF THE PARTIES

4 Prior to the filing of an administrative complaint, the parties have agreed to resolve  
5 TVN No. 34347 via settlement. Enforcement and the Licensee agree to the following:

6 1. The parties enter into this Agreement to avoid the time and expense of further  
7 litigation.

8 2. The Licensee explicitly waives the right of further administrative review of all  
9 matters related to the above-referenced case and TVN. Furthermore, the Licensee hereby  
10 voluntarily withdraws its request for a hearing in this matter.

11 3. The Licensee stipulates to the violation set forth in TVN No. 34347.  
12 Specifically, on or about January 31, 2012, the above-named Licensee or employee thereof  
13 sold or permitted to be sold a tobacco product to a person under the age of 18, contrary to  
14 RCW 26.28.080.

15 4. The Licensee acknowledges that this is the Licensee's first violation of this type  
16 within a twenty-four (24) month period, which carries a standard monetary penalty of one  
17 hundred dollars (\$100).

18 5. In consideration of and for this settlement agreement, the Licensee agrees to pay  
19 a monetary penalty of eighty dollars (\$80.00) for the above-referenced violation.

20 6. The Licensee shall pay the monetary penalty of eighty dollars (\$80.00) no later  
21 than thirty (30) days after the date of the Final Order of the Board. **Payment shall be sent to:**


24 7. In the event that the Licensee fails to make a full and timely payment of the  
25 monetary penalty as required in Section II, Paragraph 6, then the standard penalty of one  
26 hundred dollars (\$100.00) shall be imposed.


1           8.       The undersigned parties declare that the terms of this Settlement Agreement are

4 TVN.


5           9.       The parties recognize that this settlement agreement is subject to approval by  
6 the Washington State Liquor Control Board.




