FERGUSON, Attorney General, and JUSTIN KJOLSETH, Assistant Attorney General, and the Licensee, NORTH ASH LLC, d/b/a SUPER C STORE (Licensee) through its representative VENUS GHEBREMESKEL, hereby enter into this stipulated settlement agreement for Liquor Control Board Cases T-590 and T-592.

**I. INTRODUCTION**

1. The Washington State Liquor Control Board Education and Enforcement Division issued an Administrative Violation Notice No. 4T3122A ("First AVN") on May 04, 2013, to the above-named Licensee specifying that on May 02, 2013 licensee violated WAC 314-34-030, which prohibits licensed tobacco retailers from possessing unstamped cigarettes.


1 products license. Licensee shall no longer be authorized to sell cigarettes or other tobacco


