22 maintained in this case, now therefore:


23 IT IS HEREBY ORDERED that the Stipulated Settlement Agreement in the above

The Washington State Liquor Control Board Education and Enforcement Division (Enforcement) by and through its attorneys ROBERT W. FERGUSON, Attorney General, and ISAAC WILLIAMSON, Assistant Attorney General, and the Licensee, KATHI LOU COLLIER d/b/a HILLTOP TEXACO, hereby enter into this stipulated settlement agreement for Liquor Control Board Case No. T-591.

**I. INTRODUCTION**

The Washington State Liquor Control Board, Enforcement and Education Division issued Tobacco Violation Notice (TVN) No. 2R3145B to the Licensee, alleging that on or about May 25, 2013 the Licensee or employee thereof sold or supplied tobacco to a person under the age of eighteen (18) contrary to RCW 26.28.080.

Enforcement and the Licensee wish to enter into a settlement agreement concerning the above-referenced TVN.

1 **II. AGREEMENT OF THE PARTIES**

2 Enforcement and the Licensee agree to the following:

3 1. Enforcement and the Licensee enter into this agreement to avoid the time and  
4 expense of further litigation. The Licensee explicitly waives the right of further administrative  
5 review of all matters related to the above-referenced complaint. The Licensee hereby  
6 voluntarily withdraws its request for a hearing in this matter.

7 2. This agreement constitutes the final written expression of all the terms of this  
8 agreement and is a complete and exclusive statement of these terms.

9 3. The Licensee stipulates to the violation set forth above and referenced in the  
10 TVN: On or about May 25, 2013, the above-named Licensee, or employee(s) thereof,  
11 sold/supplied tobacco to a person under the age of eighteen (18) contrary to RCW 26.28.080,  
12 and is subject to the penalties in RCW 70.155.100.

13 4. The Licensee acknowledges this is the Licensee's first violation of this type  
14 within a twenty-four (24) month period. The standard penalty is either a suspension or revocation  
15 of the tobacco license, or a one hundred dollar (\$100) monetary penalty.

16 5. The Licensee agrees to pay a total monetary penalty of seventy dollars (\$70) for  
17 the above-referenced violation. This amount shall be paid within thirty (30) days of the date of  
18 the final order of the Washington State Liquor Control Board. **Payment shall be made on the**

22 6. The undersigned parties declare that the terms of this Settlement Agreement are  
23 completely read, wholly understood, and voluntarily accepted for the purpose of making a full  
24 and final compromise and settlement of any and all claims arising from the above referenced  
25 TVN.


