

The Washington State Liquor Control Board Education and Enforcement Division (Enforcement) represented by its attorneys ROBERT M. MCKENNA, Attorney General, and ISAAC WILLIAMSON, Assistant Attorney General, and the Licensee, JANG BIU MAH d/b/a BARGAIN BEVERAGES, hereby enter into this stipulated settlement agreement for Liquor Control Board Case No. T-565.

I. INTRODUCTION

The Washington State Liquor Control Board, Enforcement and Education Division charged the above-named Licensee, in Tobacco Violation Notice (TVN) No. 33425 with the following alleged violation of the Washington State Liquor Control Board rules and regulations:

On or about May 17, 2012, the above-named Licensee, or employee(s) thereof, sold/supplied tobacco to a person under the age of eighteen (18) contrary to RCW 26.28.080, and is subject to the penalties in RCW 70.155.100.

1 Enforcement and the Licensee wish to enter into a settlement agreement concerning the
2 above-referenced Tobacco Violation Notice.

3 **II. AGREEMENT OF THE PARTIES**

4 Enforcement and the Licensee agree to the following:

5 1. Enforcement and the Licensee enter into this agreement to avoid the time and
6 expense of further litigation. The Licensee explicitly waives the right of further administrative
7 review of all matters related to the above-referenced violation. The Licensee hereby
8 voluntarily withdraws its requests for a hearing in this matter.

9 2. This agreement constitutes the final written expression of all the terms of this
10 agreement and is a complete and exclusive statement of these terms.

11 3. The Licensee stipulates to the violation set forth above and referenced in the
12 TVN: On or about May 17, 2012, the above-named Licensee, or employee(s) thereof,
13 sold/supplied tobacco to a person under the age of eighteen (18) contrary to RCW 26.28.080,
14 and is subject to the penalties in RCW 70.155.100.

15 4. The Licensee acknowledges this is the Licensee's first violation of this type
16 within a twenty-four (24) month period. The standard penalty is either a suspension or revocation
17 of the tobacco license, or a one hundred dollar (\$100) monetary penalty.

18 5. The Licensee agrees to pay a total monetary penalty of eighty dollars (\$80) for
19 the above-referenced violation. This amount shall be paid within thirty (30) days of the date of
20 the final order of the Washington State Liquor Control Board. **Payment shall be made no**
21 **later than 4:00 p.m. on the applicable date and sent to:**


24 6. In the event that the Licensee does not make a timely payment, the Licensee
25 shall serve a suspension of its tobacco license, pursuant to RCW 70.155.100; the dates and
26 times of which shall be set by the Washington State Liquor Control Board.

1 7. The undersigned parties declare that the terms of this Settlement Agreement are
2 completely read, wholly understood, and voluntarily accepted for the purpose of making a full
3 and final compromise and settlement of any and all claims arising from the above referenced
4 TVN.

5 8. The parties recognize that this settlement agreement is subject to approval by
6 the Washington State Liquor Control Board.
