I understand under the provisions of RCW 66.28.010:

- No person, officer, investor, or entity with an ownership interest in the business I am licensing has any financial interest, directly or indirectly, in any manufacturer, importer, or distributor of alcoholic beverages, nor have they any ownership, stock* or investment in any brewery, microbrewery, winery, distributor, distillery, or liquor supplier.
- I have not, nor has any officer, investor, or entity with an ownership interest in the business I am licensing received, directly or indirectly, any money, financial assistance, advertising, sponsorship or promotion fees from any manufacturer, importer or distributor, of alcoholic beverages.
- I have not, nor has any officer, investor, or entity with an ownership interest in the business I am licensing entered into any oral or written advertising, promotion, or trademark agreement, arrangement or contract with any manufacturer, importer or distributor of alcoholic beverages prohibited by RCW 66.28.010.
- No subsidiary, affiliated, or parent company of the business I am licensing has any financial interest in or receives any money from any manufacturer, importer, or distributor of alcoholic beverages, nor has any subsidiary, affiliated, or parent company of the business I am licensing entered into any oral, written, advertising, promotion or trademark agreement, arrangement, or contract with any manufacturer, importer, or distributor of alcoholic beverages that is prohibited by RCW 66.28.010.
- I have not rented any real property from a landlord who manufactures, imports or distributes alcoholic beverages. If the business I am licensing will be a spirits, beer, wine restaurant it may be leased from and located on the premises of a licensed brewery, microbrewery, winery, or distillery
- I understand the restrictions of RCW 66.28.010 remain in effect as long as I am a party of interest in a retailer of alcoholic beverages.

*Unless the stock is held in a mutual or retirement fund in which I have no controlling or voting interest.
