OFFICE OF THE WASHINGTON STATE LIQUOR CONTROL BOARD MEETING

July 7, 2004

The regular meeting of the Washington State Liquor Control Board was called to order at 10:00 a.m., on Wednesday, July 7, 2004 in the Board conference room, 3000 Pacific Avenue SE, Olympia, Washington, by Board Member Roger Hoen. Board Member Vera Ing was present. Tony Kim, Administrative Assistant to the Board summarized the minutes.

Board – Approval of Minutes

Board Member Ing reviewed the minutes of April 21, May 4, May 5, May 18, May 19, June 1, and June 22 for approval. Board Member Hoen seconded the motion, and it was carried.

Policy, Legislative and Media Relations Division – Approval for Rule Making – Rules Regarding General Requirements for Liquor Licensees

Teresa Berntsen, Rules Coordinator

Ms. Berntsen recommended Board approval for final rule making for technical changes to rules in chapter 314-11 WAC, which outlines general requirements for liquor licensees.

Liquor Enforcement Officers have discovered wording errors in four WACs that can be corrected

through technical changes (please see attached). These changes will help clarify the rules for staff and for licensees.

WAC 314-11-015: What are my responsibilities as a liquor licensee?

WAC 314-11-020: What are the guidelines regarding sales to persons under twenty-one years of age and where persons under twenty-one are allowed on a licensed premises?

WAC 314-11-070: During what hours can I sell or serve liquor?

WAC 314-11-065: What type of liquor is allowed on a licensed premises?

BACKGROUND

The agency filed an expedited rule making notice on the proposed changes and sent a notice to stakeholders on May 11, 2004. The comment period ended June 25, 2004. No public comments were received.

RECOMMENDATION AND PROCESS

Staff recommended that the Board approve final rule making on the proposed rules as written. If approved, Ms. Berntsen would file the attached language with

the Office of the Code Reviser, and the revised rules would become effective 31 days after.

Board Member Ing moved for approval. Board Member Hoen seconded the motion, and it was carried.

Retail Services Division - Lease Proposal, Liquor Store #81, Renton (Highlands)

The lease for the temporary site of Store No. 081, located at 2806 NE Sunset Boulevard, Renton, has been extended several times and will now expire on December 31, 2004.

BACKGROUND

Store No. 081 was formerly located in a stand-alone building on the east side of Sunset Boulevard. The store had been there for many years and the lease was renewed for 5 years in 2000 when no suitable new location could be found. Subsequently the property was sold to Walgreen's Pharmacy, along with several neighboring parcels, and the liquor store lease was terminated as of December 31, 2002. Following an exhaustive search for a new permanent space for this busy store, our landlord offered a 3,000 square foot "temporary" space on the west side of Sunset Boulevard so that we could maintain service to our customers in the area. Most of the licensee accounts were transferred either to Store #025 in downtown Renton or to Store #114 in Newcastle. Although staff has evaluated several possible sites, the site being proposed was identified many months ago as the preferred long-term site. Negotiations with the landlord in California have been very slow.

PROPOSAL #1 – SUNSET PLAZA SHOPPING CENTER

The Lessor, Louis Family LLC, represented by Lee Shephard of R. J. Hallissey Co., Inc., has proposed a ten (10) year lease in 4,550 square foot space at 3176 NE Sunset Boulevard in Renton. The new

per month, or \$23.25 per square foot per year, during Years 4-6, and \$9,574.00 per month, or \$25.25 per square foot per year, during Years 7-10. It is anticipated that the space will be ready for fixturing in September 2004.

The Lease may not be terminated during the initial five (5) years of the lease term, except pursuant to Paragraph 2, if applicable, or if Lessor(s) is in default under this agreement and fails to cure such default within 30 days after receipt of written notice of the default. During Years 6 through 10, the Lease may be terminated by either party with a six (6) month written notice from the first of the month following. If the Board terminates the Lease, the remaining portion of the then unamortized improvement costs, based on an initial amount of \$90,000.00, will be due the Lessor.

If the Lessor terminates the Lease during the second five (5) years, a payment of \$15,000.00 to help defray moving expenses will be due the Board.

At the Board's option, the Lease may be renewed for a further period of 5 years with rent to be negotiated at the time the option is exercised. Additional repairs and/or improvements may be required for lease renewal.

The Lessors have agreed to remodel the premises per the Board's "General Specifications..." and a floor plan provided by Store Development, including the exterior store sign. Although there is not currently space for the liquor store on the shopping center pylon sign, Lessors have agreed that the liquor store will be included in 3rd position if they are able to renovate the existing pylon sign.

Lessors have agreed that the Board will have the "first right of opportunity" to obtain additional space if any adjacent space becomes available. They have also agreed to the provisions of Appendix A, "Areas of Responsibility", as attached.

Sales/sq ft: FY03 = \$622 (average for all state liquor stores was \$607 for FY03)

NOTE: Retail sales actually decreased by more than 17% in 2003 due to the small temporary space and poor parking. It is anticipated that sales will again increase when the store moves into the larger, more visible site with better parking.

Profitability: FY02 = 10.5% while the average profit for all state stores was 8.8%.

NOTE:2002 was the last full year the store was in its previous permanent location. Lease renewal = 9% without any of the anticipated sales increase.

ADDITIONAL DATA:

A busy independent grocery store, Saars Marketplace, anchors Sunset Plaza Shopping Center and Goodwill is moving into the shopping center. Current rental rates in Sunset Plaza are \$15 to \$17 per square foot range + over \$4.00/sq ft triple net charges. Rates in other spaces in the area ranged from \$14.50 per square foot, triple net, in a non-anchored center to nearly \$25.00 per square foot in a small, new non-anchored center with poor ingress/egress.

Other liquor store lease rates in area:

#114 Newcastle – 4,500 sq ft @ \$7,500.00/mo, or \$20.00/sq ft/yr, in Yrs 1-5 \$8,250.00/mo, or \$22.00/sq ft/yr, in Yrs 6-10

#115 Bellevue-Eastgate – 5,068 sq ft @ \$8,636.72/mo, or \$20.45/sq ft/yr, in Yrs 1-3 \$9,270.22/mo, or \$21.95/sq ft/yr, in Yrs 4-6 \$10,114.88/mo, or \$23.95/sq ft/yr, in Yrs 7-10

NOTE: Store #114 is in a Safeway-anchored center and Store #115 is in a busy Albertson's-anchored, along with many other neighborhood tenants.

Ms. Lewis recommended approval of Lease Proposal to relocate Store #081 to Sunset Plaza.

Board Member Ing moved for approval. Board Member Hoen seconded the motion, and it was carried.

Retail Services Division – Lease Extension, Liquor Store #154, Puyallup (Summit Canyon); Suzanne Lewis, Property Specialist

The 10-year lease for Store No. 154, located at 10417 Canyon Road East, Puyallup, WA, will expire on August 31, 2004.

The Lessor, Roger Miller of Summit Development Company Puyallup LLC, has agreed to a six (6) month extension of our current lease, effective September 1, 2004. During this extension period, the rent will be \$3,600.00 per month, or \$10.57 per square foot per year, a 17% increase. All other terms and conditions of the current lease shall remain the same.

We currently pay \$3,066.00 per month, or \$9.00 per square foot per year, for a 4,088 square foot space. Gross sales for FY 2003 were \$2,347,279 with Class H Sales at 16.3%.

Board Member Ing moved for approval. Board Member Hoen seconded the motion, and it was carried.
