OFFICE OF THE WASHINGTON STATE LIQUOR CONTROL BOARD MEETING

October 6, 2004

The regular meeting of the Washington State Liquor Control Board was called to order at 9:00 a.m., on Wednesday, October 6, 2004 in the Board conference room, 3000 Pacific Avenue SE, Olympia, Washington, by Board Member Roger Hoen. Board Member Vera Ing was present. Tony Kim, Administrative Assistant to the Board summarized the minutes.

Retail Services Division – Contract Liquor Store (CLS) Manger Appointment, CLS #584, Ridgefield; Earl Hill, District Manger

The Ridgefield store will be a stand-alone store located at 214 Pioneer, Ridgefield, Washington. The population of Ridgefield is approximately 2,100. This store is located 10.2 miles from Store #582 Woodland, 7.6 miles from #673 Salmon Creek and 12.8 miles from #108 Hazel Dell. The building is 1000 sq. ft. with a front sales area of approximately 520 sq. ft. It has good access for deliveries, and street parking is available.

62 applications were requested for this opening, 7 received, and 5 applicants were interviewed. The applicants were interviewed by a panel consisting of: Earl Hill, hiring District Manager, Robbi Mettler-Stern, District Manager, and Bill DiLorenzo, Audit & Loss Prevention Manager. After the interviews were conducted, the selected candidate was Scott Hughes.

Scott graduated from Colombia River High School and attended the University of Portland to achieve a Bachelor of Business Administration Degree. For the last five years Scott has owned and operated the Ridgefield Hardware Store. He has served 3.5 years with the Ridgefield Planning Commission. His wife, Cathy has twenty-one years of retail experience and will help with the store operations.

Scott plans to expand product selection. He is purchasing the building and plans to expand the hours of operation. One of Scott's goals is to provide the community with a long-term business partnership and the best in customer service. He plans to increase sales by 20% each year for 4 years. He also plans to add tobacco products by 2005.

References were checked and Scott was described as a sensible person, high energy level, extremely smart, loves community, hard worker, takes pride in job well done, integrity, faithful, great customer service, highly motivated, honest & reliable, and has excellent people skills. Therefore, Mr. Hill recommended the appointment of Scott Hughes as the new Contract Liquor Store Manager for the Ridgefield Contract Store #584, effective November 1, 2004. Board Member Ing moved for approval. Board Member Hoen seconded the motion, and it was passed unanimously.
