Board Member Hoen moved for approval. Chairman Long seconded the motion, and it was carried.

Financial Services Division – Final Rule Making Regarding Beer and Wine Taxes

Kathy Payne, Tax Accountant

Ms. Payne recommended that the Board proceed with final rule making to revise several rules in chapter 314-19 WAC, which outlines the requirements for paying Washington State beer and wine taxes.

WHY RULE MAKING IS NEEDED

Changes to chapter 314-19 WAC are needed to:

Clarify language in the rules, and in some places add more detail, for issues that cause confusion for customers.

Implement Substitute Senate Bill 6655, passed during the 2004 legislative session, which will take effect on January 1, 2005. The law change will allow an authorized representative of an out-of-state brewery or winery to ship beer and wine into Washington State for resale. Currently only the actual brewery or winery may ship beer or wine into Washington for resale. The law will require persons who ship foreign-produced beer or wine into Washington for resale to get a Certificate of Approval license, just like suppliers of U.S. product.

RULE MAKING PROCESS

The Board held a public hearing on these changes on October 6, 2004. The comment period ended October 15, 2004.

If the Board approves the final rule making, the Rules Coordinator will prepare a Concise Explanatory Statement to go to all persons who gave comment. The Rules Coordinator will then file the rules a final time with the Code Reviser, and the rules would become effective January 1, 2005 to coincide with the effective date of SSB 6655.

Board Member Hoen moved for approval. Chairman Long seconded the motion, and it was carried.

Board Member Hoen reviewed the minutes of October 26 and October 27 for approval. Chairman Long seconded the motion, and it was carried.
