Policy, Legislative, and Media Relations Division – Approval of Proposed Rule Making (CR 102) Establishing a Fee for a Wine Shippers' Permit and Repealing the Reciprocal Wine Shipping Program

Ms. Madson requested that the Liquor Control Board approve the filing of notice of proposed rule making for rules establishing a fee for a wine shipper's permit and repealing rules implementing the existing wine reciprocity program.

Board member Vera Ing suggested that since there was a sunset on the bill, we may need to have a sunset on the rule. Staff suggested that an expiration date on

the bill simply requires the legislature to take a look at circumstances in two years and make a decision to continue the original provisions or make changes. We will learn much in the next few years about how this shipping privilege will work on the ground. The legislature could make changes during the 2007 session. Rules can be changed as needed. Discussion followed.
