OFFICE OF THE WASHINGTON STATE LIQUOR CONTROL BOARD Board Meeting /August 2, 2006

The regular meeting of the Washington State Liquor Control Board was called to order at 10:00 a.m., on Wednesday, August 2, 2006 in the Board conference room, 3000 Pacific Avenue S.E., Olympia, Washington, by Chairman Merritt D. Long. Board Member Roger Hoen and Vera Ing were present. Tony Kim, Administrative Assistant to the Board summarized the minutes.

Licensing and Enforcement Division—Darkened House (Sports/Entertainment License); Rex Prout, Assistant Chief; Karen McCall, Licensing Manager

The Enforcement and Education Division, with the concurrence of the Licensing Division, recommended holders of the Sports/Entertainment License be authorized to allow consumption of alcohol within the darkened seating portions of the venue during entertainment activities. This recommendation is subject to the following provisions:

- The Board approves darkened house events only after notification to the local authority as identified to the Licensing Division and approval by the designated local authority. The notification will clearly state:
 - Primary responsibility for the control of the darkened area of the establishment will rest with the licensee and local law enforcement authorities.
 - The Board will not entertain contradictory recommendations from subdivisions of the local jurisdictions.
- Liquor Enforcement Officers will only be required to work within the areas of the venue where there is an environment to safely support enforcement activities.
- Permission for darkened house activities will be in the form of a standard addendum attached to the existing operating plan.
- Violation of the darkened house addendum to the operating plan will be viewed as an aggravating factor to a violation rather than a primary enforcement issue.
- Licensing and Enforcement will coordinate to create:
 - o A specific notification to local authorities.
 - o An operating plan addendum.
 - o Instructions for licensees to apply for the privilege.

• Enforcement headquarters will create written guidelines for all enforcement staff in regard to this change.

If approved, Enforcement and Licensing will coordinate for expeditious implementation of this recommendation.

Board Member Ing moved for approval. Board Member Hoen seconded the motion, and it was passed unanimously.

Policy, Legislative and Media Relations Division—Approval of Proposed Rule Making (CR 102) Implementing Direct Shipment of Wine to Washington Consumers by U.S. Wineries and Allowing U.S. Beer and Wine Manufacturers to Self-distribute Their Products to Licensed Washington Retailers; Pam Madson, Rules Coordinator

Ms. Madson requested that the Board to approve the filing of notice of proposed rule making for implementing direct shipment of wine to Washington consumers by U.S. wineries and allowing U.S. beer and wine manufacturers to self-distribute their products to licensed Washington retailers.

Process

If approved, Ms. Madson will file a notice of proposed rule making (CR 102) with the Office of the Code Reviser. A notice will be sent to interested parties for input and a public hearing date will be set.
